ORDINANCE NO. 25

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CLARKS GROVE TO INCLUDE CERTAIN PLATTED LAND.

Whereas, a petition has been filed with the governing body of the Village of Clarks Grove, Minnesota, signed by all of the owners of the following described real estate to have such land included within the Village of Clarks Grove, Minnesota.

Commencing at a point 896.95 feet south of the southeast corner of Outlot 3, Block B on the Southerly extension of Easterly line of said Outlot 3, thence Westerly 150 feet to the point of beginning of the property to be described herein; thence Northerly 30 feet; thence Westerly 80 feet; thence Southerly 130 feet; thence Easterly 80 feet; thence Northerly 100 feet to place of beginning;

ALSO

Beginning at a point 896.95 feet south of the southeast corner of Outlot 3, Block B on the southerly extension of Easterly line of said Outlot 3; thence Southerly 100 feet; thence Westerly 150 feet; thence Northerly 100 feet; thence Easterly 150 feet to the place of beginning;

ALSO

Beginning at a point 1046.95 feet south of the southeast corner of Outlot 3, Block B on the Southerly extension of Easterly line of said Outlot 3; thence Southerly 120 feet; thence Westerly 150 feet; thence northerly 120 feet; thence Easterly 150 feet to the place of beginning;

ALSO

Commencing at a point 1046.95 feet south of the southeast corner of Outlot 3, Block B on the Southerly extension of Easterly line of said Outlot 3; thence Westerly 150 feet to the point of beginning of the property to be described herein; thence Southerly 120 feet; thence Westerly 80 feet; thence Northerly 120 feet; thence Easterly 80 feet to the place of beginning;

ALSO

Commencing at a point 996.95 feet South of the Northeast corner of the Northeast Quarter of the Northeast Quarter of Section 3, Township 103, Range 21, which corner is also the Southeast corner of Outlot 3, Block B, Village of Clarks Grove, Minnesota, on a Southerly extension of the Easterly line of said Outlot 3; thence South 50.0 feet; thence West 230 feet; thence North 50.0 feet; thence East 230 feet to the point of beginning. For purposes of a public street or road.

The above lots being in the Northeast Quarter of the Northeast Quarter of Section 3, Township 103 North, Range 21 West of the 5th P.M.

Outlot 3, Block B, above referred to is in the Village of Clarks Grove, Minnesota, as platted and recorded in Book 4 of Plats, page 160, office of the Register of Deeds in and for said county.

The Village of Clarks Grove does ordain:

Section 1. That the annexation will be to the best interests of Clarks Grove and to the territory affected; that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 2. That the property hereinbefore described be and the same is hereby annexed to, and included in the village of Clarks Grove as effectually as if it had originally been a part thereof.

Section 3. That this ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State and from and after its passage and publication.
