ORDINANCE NUMBER 32.

An ordinance annexing certain lots and blocks to the Village of Amboy: The Village Council of the Village of Amboy do ordain as follows:

Sec. 1. That the following described platted property and out lots adjacent to, and abutting upon the incorporated Village of Amboy, be and the same are hereby annexed to such Village and shall become a part of such Village as effectually as if they had been originally a part thereof. To-wit: All that part of Randall's Addition to the Village of Amboy, consisting of out lot "A", out lot "B", out lot "C", lots one to three inclusive, block one (1 to 3, BLK. 1); lots one to seventeen inclusive, block two (1 to 17, BLK. 2); lots one to seventeen inclusive, block three (1 to 17, BLK. 3); lots one to three inclusive, block four (1 to 3 BLK. 4), and all streets and alleys as the same appear in that certain platt of said Randall's Addition now on file in the office of the Register of Deeds for and in Blue Earth County, Minnesota.

Sec. 2. This ordinance shall take effect and be in force on and after its approval and publication.

Ordinance Number 32.

An ordinance annexing certain lots and blocks to the Village of Amboy:
