That under Chapter 951, Laws of 1971, State of Minnesota, (487.01 Subd. 9 (1)), Affiant is required to file a Consent to become the County Judge of the Counties of Norman, Clearwater and Mahnomen, Minnesota, which have been combined, under said Chapter, into one County Court District; or, a Consent to become the County Judge of Norman County; or, a consent to become the County Judge of a combination of Norman and Clearwater, and/or Mahnomen Counties, Minnesota, should the counties separate into separate County Courts, and, in the event said counties have separated, and then Norman County combines with one, or the other, of said counties of Clearwater and/or Mahnomen;

Affiant further states that he is the duly elected, qualified and acting Probate Judge in and for Norman County, Minnesota, the most populous of the three counties, by both the latest unofficial figures and the last official U.S. Census figures, as affiant verily believes. Affiant does hereby Consent to become the County Judge of the Counties of Norman, Clearwater and Mahnomen, Minnesota; or, the County Judge of the County of Norman, should the counties separate, or in the event they have separated; and further, Affiant consents to become the County Judge of a combination of counties of Norman, and Clearwater, and/or Mahnomen, in the event they have separated, or shall separate, and rejoin into a District.

Further Affiant saith not, save that this instrument is executed for the sole purpose of covering fact situations not contemplated when Affiant first gave his Consent and Oath, which were duly filed in the Office of the Secretary of State, State of Minnesota, on August 9, 1971.


