ORDINANCE NO 7 417

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN  
LANDS ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the Council; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is ten (10) acres of unplatted land, no part of which is included within the limits of any incorporated city, village or borough; and

WHEREAS, the petition was signed by all the owners of the territory therein described; and

WHEREAS, copies of such petition have been filed with the Town Board of Sparta Township, the County Board of Chippewa County, and the Municipal Commission of the State of Minnesota, proof thereof being on file with the City Clerk of the City of Montevideo; and

WHEREAS, more than sixty (60) days have elapsed since such filing and no objections have been received under Minnesota Statutes 414.033, subdivision 5; and

WHEREAS, the land described in the petition abuts upon the city limits at the Westerly boundary thereof;

THE CITY OF MONTEVIDEO DOES ORDAIN:

Section 1. Determination by City Council: The City Council hereby determines: (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village or borough.

Section 2. Territory Annexed: The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had

originally been a part thereof:

The South ten (10) acres of a tract of land in Section Twelve (12), Township One Hundred Seventeen (117), Range Forty-one (41), described as follows: Commencing at the southeast corner of said section 12, running thence north along the east line of said Section 21 chains and 70 links (1432.2 feet); thence west at right angles to said east section line 14 chains (924.0 feet) to the right of way of the Chicago, Milwaukee & St. Paul Railway Company; thence southeasterly along said right of way to the south line of said section; thence east along said south line 1 chain and 83 links (120.78 feet) to the place of beginning. Containing 20 acres by Government Survey. EXCEPT a strip, belt or piece of land 100 feet wide extending across from the east side to the north side, conveyed to the C.M. & St. Paul Railway Co., as now located and established across said land for change of line. Also conveying all that part of the above described 20 acres lying north and east of the above described 100 foot strip. Also excepting a piece of land conveyed to the Moyer Manufacturing Company, described as follows: beginning at the southeast corner of Section 12, Township 117, Range 41, and running thence north 4 chains and 28 links (282.48 feet) to the new right of way of the C.M. & St. Paul Railway Company; thence northwesterly along the line of the new right of way until the same intersects a line drawn parallel with the south line of said section and 6 chains and 6 links (400.00 feet) north therefrom; thence west 6 chains and 14 links (405.24 feet) to the line of the old right of way of said Railway Company; thence southeasterly along the easterly line of said old right of way to the south line of said section; thence east 1 chain and 83 links (120.78 feet) to the place of beginning. Containing 2.50 acres, reserving a strip of land 30 feet wide for street purposes along the northeasterly side of said old right of way. LESS the northerly 175 feet of the above described parcel and also LESS the following described parcel: Beginning at a point that is 259 feet west of the southeast corner of Section 12, Township 117, Range 41, and north at right angles thereto a distance of 440 feet; thence continue north 100 feet; thence west on a line that is parallel to the said south line of Section 12, a distance of 297.6 feet, to the easterly right of way line of the "Milwaukee" Railroad spur track; thence southeasterly along said right of way line 122.6 feet to a point that is 440 feet north of the south line of said Section 12; thence east on a line that is parallel to the south line of said Section 12, a distance of 226.6 feet to point of beginning. Containing 0.6 acres.

The above tract containing 10.0 acres, more or less.


Section 3. Zoned IP: That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned as IP (Industrial Park).

Section 4. Filing: The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Town Clerk of Sparta Township, the Secretary of State of the State of Minnesota, the County Auditor and the Register of Deeds of Chippewa County.




Section 5. Effective Date: This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.
