

ORDINANCE NO. 544

An Ordinance Extending the Corporate Limits of the City of Willmar,
A Municipal Corporation of the State of Minnesota,
to Include Certain Land Not Exceeding 200 Acres.

WHEREAS, The following described land is owned by the City of Willmar, Minnesota, and whereas the said property abuts upon the City and is so conditioned as to be properly subject to city government and since annexation thereof will be to the best interests of the City of Willmar and of the territory to be annexed.

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar as follows:

Section 1. Annexation. The following described property is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof:

That part (0.8 Acres) of the Northeast Quarter of Section 21, Township 119, Range 35, described as follows, to-wit: Commencing at a point on the West line of said Quarter Section distant South 47.45 feet from the Northwest corner thereof; thence East and parallel with the North line of said Section 21 a distance of 430.0 feet to a point; thence South and parallel with the West line of said Quarter Section a distance of 130 feet to a point; thence West and parallel with the North line of said Quarter Section a distance of 250 feet to a point; thence deflecting Southerly $78^{\circ}42''$ a distance of 151.7 feet to a point; thence West and parallel with the North line of said Section 21 to a point on the West line of said Northwest Quarter of Northeast Quarter of said Section 21; thence North on and along said West line a distance of 280 feet to the place of beginning, EXCEPT THEREFROM:

Exception No. 1: The West 30 feet thereof;

Exception No. 2: The South 100 feet of the North 147.45 feet of the East 130 feet of the West 160 feet of the Northeast Quarter of Section 21, Township 119, Range 35.

Exception No. 3: The South 130 feet of the North 177.45 feet of the East 180 feet of the West 430 feet of the Northeast Quarter of Section 21, Township 119, Range 35.

Section 2. Best Interest of City of Willmar. That the annexation will be to the best interests of the City of Willmar, Minnesota and of the territory affected.

Section 3. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as property to be subject to city government.

Section 4. Zoning. The area above described shall be zoned Conservation Recreation.

Section 5. Effective Date. This ordinance shall take effect and be in full force from and after filing a certificate hereof with the Minnesota Municipal Commission, the County of Kandiyohi, Minnesota and the Secretary of the State of Minnesota and from and after its passage and publication.

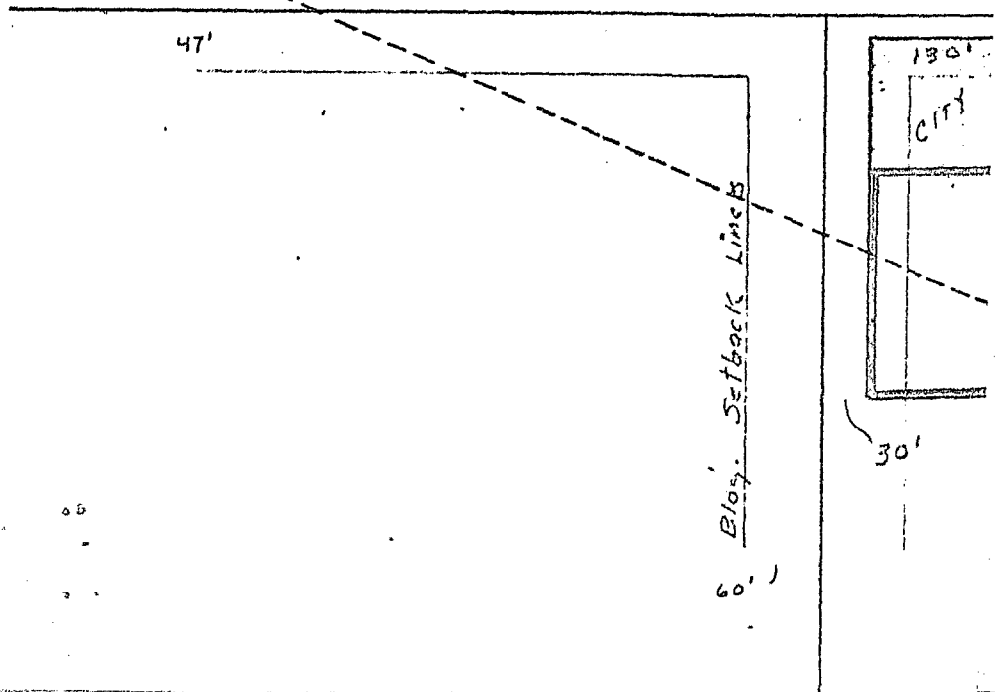
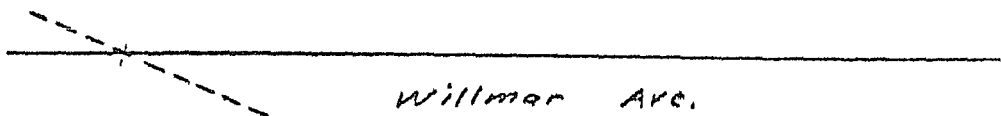
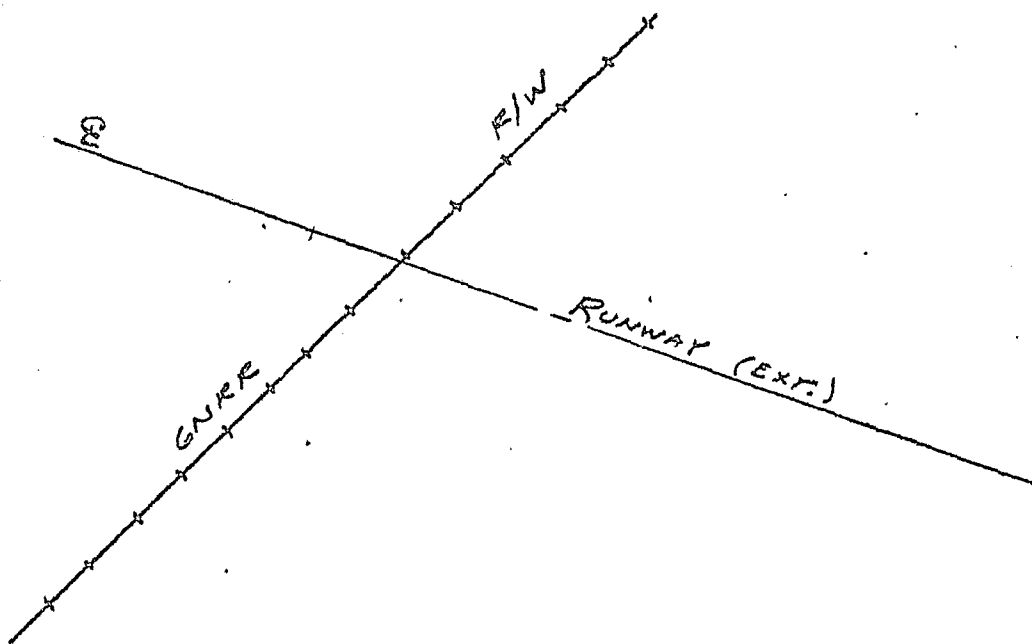
