THE CONDITION OF THIS OBLIGATION IS SUCH, That whereas, the above bounden Principal has been duly appointed to the office of Deputy Registrar of Motor Vehicles at KASSON, Minnesota, for the term beginning from 1st day of June, 1972 and until his successor is duly qualified.

NOW, THEREFORE, if the Principal shall faithfully and impartially discharge his duties in all things during his continuance in office without fraud, deceit or oppression, and pay over without delay to the office entitled by law thereto all moneys, property or things of value which shall come into his hands by virtue thereof, then this obligation shall be void, but otherwise it shall remain in full force and effect in the respective amounts for the respective periods covered hereby as hereinafter stated, to-wit:

From January 1st to December 31st of each year, both dates inclusive, Ten Thousand and no/100 DOLLARS (\$ 10,000.00), but from January 1st to March 15th of each year, both dates inclusive, and from November 15th to December 31st of each year, both dates inclusive, an additional amount of Forty Thousand and no/100 DOLLARS (\$ 40,000.00), a total amount of Fifty Thousand and no/100 DOLLARS (\$ 50,000.00), but the Surety's liability under this bond shall not be cumulative from year to year.
