2 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF APPLETON TO
3 INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE VILLAGE LIMITS.

4 WHEREAS, a certain petition dated December 15, 1971, requesting annexation
5 of the territory hereinafter described was duly presented to the council on
6 the 15th day of December, 1971; and

7 WHEREAS, the quantity of land embraced within the area described in the
8 petition and bounded as described is 1.121 acres of platted land, no part of
9 which is included within the limits of an incorporated city, village, or
10 borough; and

11 WHEREAS, the petition was signed by all owners and

12 WHEREAS, no objection to the annexation have been received from the town
13 board, the county board, or the governing body of any municipality whose
14 boundaries abut the boundaries of the land to be annexed; and

15 WHEREAS, the land described in the petition abuts upon the village limits at
16 the south boundary thereof; The council of the Village of Appleton,
17 Minnesota, ordains:

18 Section 1. The village council hereby determines (1) that the
19 annexation will be to the best interests of the village and of the territory
20 affected; (2) that the territory described herein abuts upon the village
21 limits and is urban or suburban in character; and (3) that none of said
22 territory is now included within the limits of any city, village, or borough.

23 Section 2. Territory Annexed. The corporate limits of the village are
24 hereby extended to include the platted land described as follows and the
25 same is hereby annexed to and included within the village as effectually as
26 if it had originally been a part thereof; That part of the Southwest one-
27 quarter of the Southeast one-quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Fourteen (14),
28 Township One Hundred Twenty (120), Range Forty-Three (43); beginning sixty
29 (60) feet due east of the northeast (NE) corner of Block One (1) of Beyer's
30 Addition to the Village of Appleton; thence east three hundred forty-four (344)
31 feet; thence south one hundred forty-two (142) feet; thence west three hundred
32 forty-four (344) feet; thence north one hundred forty-two (142) feet to the
point of beginning.
