PROPOSED ORDINANCE NO. 286

ORDINANCE NO. 760

AN ORDINANCE ANNEXING CERTAIN LAND TO THE
CITY OF ST. CLOUD.

WHEREAS, A. W. and Rose Propotnik, being the owners of a certain tract of land described below, situated in Stearns County, Minnesota, have filed a petition with the City and presented said petition to the Council requesting that that certain tract of land described below be annexed to the City of St. Cloud and made a part thereof, and

WHEREAS, after due and careful investigation and consideration, it is hereby found, determined and declared:

1. That said tract of land abuts and adjoins the present corporate limits of the City of St. Cloud, and that no part lies within or abuts on any other municipality.
2. That said petitioners are the sole owners of said tract of land; and the land is platted.
3. That petitioners reside on said tract.
4. That the interests of the City of St. Cloud, and its inhabitants, and of the petitioners, will be best served by annexation of said tract of land to the City of St. Cloud.



Adopted by the Council of the City of St. Cloud, at a regular meeting held January 31, 1972, by the following vote:






