ORDINANCE NO 2059

Introduced by Councilman Glenn Hammer

WHEREAS, a certain petition dated May 31, 1972 requesting annexation of the territory here in after described was duly presented to the Council on the 12th day of June, 1972, and,

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 1.38 acres of platted land, no part of which is included within the limits of an incorporated City, Village or Borough, and,

WHEREAS, the petition was signed by all owners, and,

WHEREAS, no objection to the annexation have been received from the Town Board, the County Board or the Governing Body of any Municipality whose boundaries abut upon the boundaries of the land to be annexed, and,

WHEREAS, a public hearing was held by the governing body of the City of Albert Lea on the proposed annexation after at least a 60 day waiting period following notice of intent to annex the property, and,

WHEREAS, the land described in the petition abuts upon the City limits at the Southerly boundary thereof.

THE CITY OF ALBERT LEA DOES ORDAIN:

Sec. 1: The City Council hereby determines (1). That the annexation will be to the best interest of the City and of the territory affected; (2). That the territory described here in abuts upon the City limits and is urban or suburban in character (3). That none of said territory is now included within the limits of any City, Village or Borough.

Sec. 2: The Corporate Limits of the City of Albert Lea are hereby extended to include the platted land described as follows and the same is hereby annexed to and included with the City as effectually as if it had originally been a part thereof:

Beginning at a point which is seventy three (73) feet west of the east line of Lot thirteen (13) in Webber's Subdivision of the NW $\frac{1}{4}$ of Section Ten (10) Township One Hundred Two (102) Range Twenty One (21) West of the 5th P.M. which point is also thirty three (33) rods, eleven (11) feet and four (4) inches north of the east and west 16th line of said NW $\frac{1}{4}$ of Section Ten (10); thence west one hundred twenty (120) feet; thence south to the south line of Stevens Street (old U.S. Highway No. 65); thence northeasterly along the south line of said Street to a point which is directly south of the point of beginning thence north to the place of beginning. (1.43 Acres)

Sec. 3: That the above property is hereby zoned as R-1 Residential Property.

Sec. 4: The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.
