

I.

WHEREFORE, your Petitioner prays that the above tract of land be annexed to and made a part of the City of North Mankato.

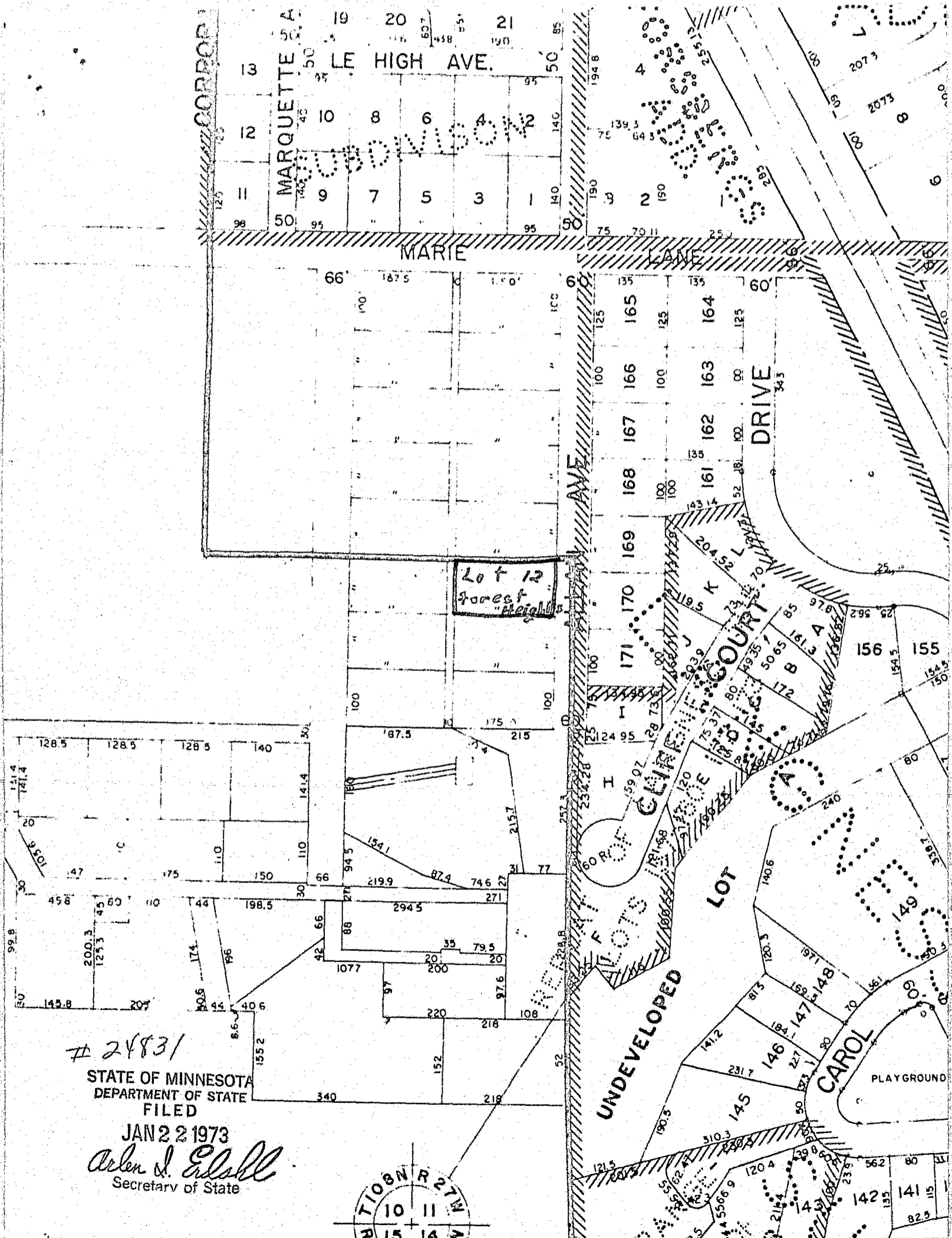





ORDINANCE NO. 536

AN ORDINANCE DECLARING CERTAIN PLATTED LAND
TO BE ANNEXED TO THE CITY OF NORTH MANKATO
AND PROVIDING ZONING THEREFOR.

The Common Council of the City of North Mankato, Minnesota, does ordain
as follows:

Sec. 1. Lot 12 of Forest Heights Subdivision of Section 10-108-27,
Nicollet County, Minnesota, according to the plat thereof on file and of
record in the office of the Register of Deeds within and for Nicollet County,
Minnesota, and any and all streets, highways or other public rights of way
within and adjacent to said described land, is hereby annexed and declared to
be a part of the City of North Mankato and to be included in the corporate
limits thereof.

Sec. 2. The above described land be and hereby is zoned R-1, Single
Family Residence District, pursuant to the Zoning Ordinance of the City of
North Mankato.

Sec. 3. This Ordinance shall take effect from and after its date of
passage and publication.
