AN ORDINANCE ESTABLISHING
THE ANNUAL VILLAGE ELECTION DAY

WHEREAS, it is desired that the annual
Village election coincide with the regular County, State and National election
day;

Prairie ordains:

THEREFORE, the Village Council of Lester

Section 1. The regular annual election
for the elective offices of the Village shall be held on the first Tuesday
after the first Monday in November of every year.

Section 2. The Village Clerk shall notify
in writing the County Auditor of McLeod County and the Secretary of State of
Minnesota upon adoption of this ordinance.

Section 3. This ordinance shall take effect
upon the Village Clerk's notice as specified in Section 2 herein.
