AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE VILLAGE OF BROWNTON.

THE VILLAGE COUNCIL OF THE VILLAGE OF BROWNTON DO ORDAIN AS FOLLOWS:

THAT THE PREMISES ADJOINING THE VILLAGE LIMITS OF THIS VILLAGE AND DESCRIBED AS FOLLOWS:

Beginning at a point 300 feet north of a point 694 feet West of Southeast corner of Northeast Quarter of Northwest Quarter of Section 32, Town 115 North, Range 29 West thence North 60 feet; thence West 296 feet; thence South 30 feet; thence West 33 feet; thence South 30 feet; thence East 329 feet to point of beginning; being also known and described as Lot 12, Block 4 and North 60 feet of Lot 13, Block 4 in Northeast Quarter of Northwest Quarter of Section 32, Town 115 North, Range 29 West, except Zimmerman's Addition, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said County and State.

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE VILLAGE OF BROWNTON.

THE VILLAGE COUNCIL OF THE VILLAGE OF BROWNTON DO ORDAIN AS FOLLOWS:

THAT THE PREMISES ADJOINING THE VILLAGE LIMITS OF THIS VILLAGE AND DESCRIBED AS FOLLOWS:

Beginning at a point 120 feet North of a point 504 feet West of the Southeast Corner of the Northeast Quarter of the Northwest Quarter of Section 32, Town 115 North, Range 29 West, thence North 72 feet; thence West 190 feet; thence South 192 feet; thence East 66 feet; thence North 120 feet; thence East 124 feet to point of beginning; being also known and described as Lot 8 and South 12 feet of Lot 9, and South 192 feet of Lot 13, Block 5 in Auditor's Plat of Northeast Quarter of the Northwest Quarter of Section 32, Town 115 North, Range 29 West, except Zimmerman's Addition, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said County and State.
