ORDINANCE TO ANNEX PART OF THE SOUTHEAST QUARTER OF  
SECTION 13, TOWNSHIP 115, NORTH RANGE 28 WEST, MCLEOD  
COUNTY, MINNESOTA, TO THE CITY OF GLENCOE.

The City Council of the City of Glencoe ordains:

Section 1. That the following described property to-wit:

Commencing at a point on the North line of the Southeast  
Quarter of Section 13, Township 115 North, Range 28 West of the 5th  
P.M. and 1148.0 feet West of the Northeast corner of the Southeast  
Quarter of said Section 13, thence South 378.79 feet to a point, thence  
West 460.0 feet to a point, thence North 378.79 feet to a point on the  
North line of the Southeast Quarter of said Section 13, thence East  
along the North line of the Southeast Quarter, a distance of 460.0  
feet to point of beginning, and which abuts upon the incorporated City  
of Glencoe be and the same hereby is annexed to said City of Glencoe  
and the same shall become a part of said city as effectually as if it  
had been a part thereof originally.

This Ordinance shall be in effect from and after its


