

Ordinance No. 577

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WILLMAR, A MUNICIPAL CORPORATION OF THE STATE OF MINNESOTA, TO INCLUDE CERTAIN LANDS OWNED BY THE CITY OF WILLMAR.

WHEREAS, The following described land is owned by the City of Willmar, Minnesota, and

WHEREAS, Said property abuts upon the City and is so conditioned as to be properly subject to City Government and since annexation thereof will be in the best interests of the City of Willmar and of the territory to be annexed.

NOW THEREFORE, Be It Ordained by the City Council of the City of Willmar as follows:

Section 1. Annexation. The following described property is hereby annexed and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof:

That part of Kandiyohi County, Minnesota, described as follows, to-wit:

The West 35 feet of the Northeast Quarter of Section 21, Township 119, Range 35.

Section 2. Best Interest of the City of Willmar. That the annexation will be to the best interest of the City of Willmar, Minnesota, and the territory affected.

Section 3. Abuts on City Limits. That the property above described abuts on city limits and is so conditioned as property to be subject to City Government.

Section 4. Zoning the Above Area. The area above described shall be zoned R-2, one and two family residents district.

Section 5. Affective Date. This ordinance shall take affect and be in full force from and after the filing of a copy of this ordinance with the Minnesota Municipal Commission, the Town Clerk of Willmar Township, the County Auditor, Kandiyohi County, and the Secretary of State, State of Minnesota, and from and after its passage and publication.




