ORDINANCE NO. 135, NEW SERIES

AN ORDINANCE DETERMINING THE ANNEXATION OF CERTAIN LAND TO BE IN THE BEST INTEREST OF THE CITY OF LUVERNE AND OF THE TERRITORY AFFECTED AND DECLARING SAME TO BE ANNEXED TO THE CITY

THE CITY OF LUVERNE DOES ORDAIN:

Section 1. The following territory, consisting of unplatted land not exceeding two hundred (200) acres in all, abutting upon the City of Luverne, Rock County, Minnesota, being so conditioned as property to be subject to municipal government and not included in any other municipality upon petition of all the owners in number, and in the best interests of the City of Luverne and of said territory, is hereby declared to be annexed to the said City, to-wit:

A tract of land beginning at the Northwest corner of Lot Six (6), Block Three (3) Westview Addition to the City of Luverne, Minnesota; thence Easterly along the North line of said Block Three (3) and the Easterly extension thereof to the Southwest corner of Block Four (4), Davis Addition to the City of Luverne, Minnesota; thence North along the West line of said Block Four (4), Davis Addition to the Northwest corner thereof; thence West along the Northerly line of the Southeast Quarter (SE 1/4) of 3-102-45 to a point 116.1 feet North of the Northerly extension of the West line of Lot Six (6), Block Three (3), Westview Addition to the City of Luverne, Minnesota; thence South along said Northerly extension to the point of beginning.

Section 2. The above described territory shall be incorporated in and become a part of the North Ward, Northwest Precinct, of the City for election purposes until otherwise designated by the City Council as provided by law.

Section 3. This ordinance shall be in full force and effect thirty (30) days after its passage and publication, and the annexation provided for herein shall be deemed final upon filing a copy hereof with the Minnesota Municipal Commission, the Rock County Auditor and the Secretary of State.
