ORDINANCE NO. 557

FEB 1974

AN ORDINANCE ANNEXING LAND TO THE CITY OF WHITE BEAR LAKE, MINNESOTA WHICH IS BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, the land hereinafter described is not included within the boundaries of any incorporated municipality, and

WHEREAS, sixty percent (60%) or more of the perimeter of this territory is bordered by land already included within the corporate limits of the City of White Bear Lake, and is deemed to be urban in character, and,

WHEREAS, the City Council feels that such annexation will be in the best interests of the City of White Bear Lake and of the affected territory.

NOW, THEREFORE, The Council of the City of White Bear Lake, Minnesota does ordain:

1. That the following described land situated in Ramsey County, Minnesota, to-wit:

Beginning at the southeast corner of Lot 060-71, Section 24, Township 30, Range 22 West; thence northerly along the extended east line of said lot of said Section 24 for a distance of 600 feet to the northeast corner of Lot 020-73 of said Section 24, thence westerly along the north line of Lots 020-73 of said Section 24 for a distance of 280 feet to the northwest corner of Lot 020-72, of Section 24; thence southly along the east right of way line of Jay Lane for a distance of 600 feet to the north right of way line of County Road F, thence easterly along said right of way for a distance of 280 feet to the point of beginning and there terminating.

AKA: The north 600 feet of the south 633 feet of the west 280 feet of the east 613 feet of the southeast 1/4 of the southwest 1/4 of Section 24, Township 30 North, Range 22 West.

be and the same is hereby annexed to the City of White Bear Lake, Minnesota.

2. That this Ordinance shall take effect and the annexation shall be deemed final after its passage, approval and publication and after a copy of such is filed with the Minnesota Municipal Commission, Ramsey County Auditor, Secretary of State of the State of Minnesota and the Clerk of the Town of White Bear.
