

Ordinance No. 2266
**AN ORDINANCE EXTENDING THE
CORPORATE LIMITS OF THE
CITY OF WINONA
TO INCLUDE CERTAIN
UNINCORPORATED LAND ABUTTING
UPON THE CITY LIMITS**

WHEREAS, a certain petition dated December 4, 1973, requesting annexation of the territory hereinafter described was duly presented to the City Council on the 10th day of December, 1973, and

WHEREAS, the land embraced within the area described in the petition is unplatted land, no part of which is included within the limits of an incorporated city, village or borough; and consists of 11.84 acres, and

WHEREAS, the petition was signed by all the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board of Commissioners, or any other governmental body; and

WHEREAS, the land described in the petition abuts upon the City of Winona limits at the south east boundary thereof; and

WHEREAS, copies of the said petition were filed with the Minnesota Municipal Commission, the concerned Town Board, the City of Winona, and the County Board of Commissioners; and

WHEREAS, the desirability of annexing said land has been carefully considered;

NOW, THEREFORE, the City of Winona does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is urban or suburban in character; and (3) none of said territory is now included within the limits of any city, village or borough.

Section 2. The corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

That part of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section One (1), Township One Hundred Six (106) North, of Range Seven (7), West of the Fifth Principal Meridian, Winona County, Minnesota, more particularly described as follows, to-wit:

Commencing at the Northeast corner of the Northwest Quarter (NW $\frac{1}{4}$) of said Section One (1); thence West along the north line of said Section One (1) at a bearing of south 87° 44' West a distance of 687.15 feet; thence south 3° 18' East a distance of 35.20 feet to the point of beginning; thence north 87° 23' 30" east a distance of 573 feet; thence south 3° 18' east a distance of 521 feet; thence south 2° 08' west a distance of 88.65 feet; thence south 48° 43' east a distance of 30 feet; thence south 41° 30' west a distance of 90 feet; thence south 54° 46' east a distance of 180 feet; thence south 25° 22' west a distance of 120 feet; thence south 19° 05' east a distance of 87.30 feet; thence south 29° 20' west a distance of 172.50 feet; thence north 70° 56' west a distance of 40 feet; thence north 44° 56' west a distance of 405 feet; thence north 79° 56' west a distance of 112.35 feet; thence north 11° 47' east a distance of 138.50 feet; thence north 10° 09' east a distance of 60 feet to a point on a tangential curve on the north side of Club View Road; thence northwesterly along said curve having a radius of 222.42 feet and a central angle of 76° 47' an arc distance of 298.07 feet to the end of said tangential curve on the east line of Club View Road; thence north 3° 18' west a distance of 397.55 feet to the place of beginning, containing 11.84 acres, more or less.

Section 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk and the County Auditor.

Section 4. This ordinance shall take effect upon its publication.
