AMENDED ORDINANCE NO. 14

An ordinance relating to the annexation of certain property of the Village of Miltona, Minnesota, and extending the corporate limits to encompass said land.

WHEREAS, High C. McWhorter, a single man, Edward Suckow, a widower, and the Miltona Development Corporation, a Minnesota corporation incorporated under the provisions of the Minnesota Non-Profit Corporation Act, being Chapter 317 of Minnesota Statutes as amended, have filed a Petition indicating that they are the sole owners of the hereinafter described property lying and being in the County of Douglas, State of Minnesota; that said land abuts upon the corporate limits of the Village of Miltona; and have Petition for the orderly annexation of said property to the Village of Miltona.

WHEREAS, the Petition therefore has been filed with the Minnesota Municipal Commission as Docket No. A-2395 "Miltona Annexation"; and

WHEREAS, the governing body of the Village of Miltona has examined said Petition, and finds that said property is so conditioned as property to be subject to municipal government; that the present pattern of physical development to the Village of Miltona necessarily provides for expansion and growth into the proposed annexed area; that the natural terrain and general topography makes such area amenable to orderly annexation; that the entire North boundary of said proposed annexation is contiguous to the southerly limits of the Village of Miltona; and that the annexation of said property would be for the best interests of the municipality, and of the territory to be effected and to be annexed.

NOW THEREFORE, the Village council of the Village of Miltona does ordain.

Section 1. That it is for the best interests of the municipality of the Village of Miltona and of the territory hereinafter described that said territory be annexed to and be made a part of municipality of the Village of Miltona.

Section IX. That the following described land, to-wit:

All that part of the North Half of the Northeast Quarter of the Southeast Quarter ( $\frac{1}{4}$  NE $\frac{1}{4}$  SE $\frac{1}{4}$ ) of Section Twenty-six (26), Township One Hundred Thirty North (130N), Range Thirty-seven West (37W) of the 5th P.M., and more particularly described as follows, to-wit: To find the point of beginning, commence at the East Quarter corner of said Section Twenty-six (26); thence South  $87^{\circ}44'$  West and along the North line of said Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$  SE $\frac{1}{4}$ ) a distance of 384 feet to the point of beginning; thence from said point of beginning thus: South  $87^{\circ}44'$  West 821 feet to a point 120 feet on a line North  $87^{\circ}44'$  East from the Northwest corner of the North Half of the Northeast Quarter of the Southeast Quarter ( $\frac{1}{4}$  NE $\frac{1}{4}$  SE $\frac{1}{4}$ ), Section Twenty-six (26), Township One Hundred Thirty (130), Range Thirty-seven (37), thence South 100 feet; thence South  $87^{\circ}44'$  West 113.27 feet to the 1/16 line; thence South  $00^{\circ}21'06''$  East 552.15 feet to the Southwest corner of the said North Half of the Northeast Quarter of the Southeast Quarter ( $\frac{1}{4}$  NE $\frac{1}{4}$  SE $\frac{1}{4}$ ); thence North  $87^{\circ}55'45''$  East and along the South line of said North Half of the Northeast Quarter of the Southeast Quarter ( $\frac{1}{4}$  NE $\frac{1}{4}$  SE $\frac{1}{4}$ ) a distance of 919.10 feet; thence North  $01^{\circ}33'$  East 656.36 feet to the point of beginning, and containing 13.67 acres more or less.

is hereby annexed to and made a part of the municipality of the Village of Miltona, and the corporate limits of the Village of Miltona shall be and are hereby extended to include and encompass the land and territory above described.

This ordinance shall take effect from and after its passage and publication in accordance with the laws of the State of Minnesota, and upon the approval of the State of Minnesota Municipal Commission; and upon filing a copy of the ordinance with the Municipal Commission; the city clerk of Miltona township, the Douglas County Auditor, and the Secretary of State of the state of Minnesota.
