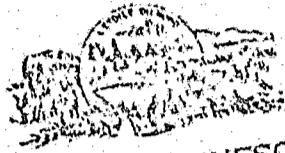





ORDINANCE NO. 602

An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation, of the State of Minnesota, to Include Certain Lands Not Exceeding 200 Acres.

Whereas, A petition has been filed with the governing body of the City of Willmar, a Municipal Corporation of the State of Minnesota, by the property owner having the sole interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota, and

Whereas, It is proposed to annex by virtue hereof to said City of Willmar said property, all of which said property is in Kandiyohi County, Minnesota, and

Whereas, The property to be annexed consists of 6.24 acres more or less, described as follows, to-wit:

All that part of the Northeast Quarter of Section 21, Township 119, Range 35, described as follows: Beginning at the Southwest corner of Lot 7 of Block 4 of Molenaar's Addition, as of public record; thence on an assumed bearing of South 22° 24' West along the Southwesterly extension of the Westerly line of said Block 4, a distance of 461.85 feet; thence on a bearing of South 70° 23' 30" East, 619.25 feet; thence on a bearing of North 22° 24' East, 415.25 feet to the Southeast corner of Lot 3 of Block 2 of said Molenaar's Addition; thence on a bearing of North 66° 04' West, 618.71 feet to the point of beginning.

Now Therefore, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best interests of the City of Willmar and area to be annexed. That the annexation will be to the best interests of the City of Willmar, Minnesota, and of the property affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City Limits and is so conditioned as property to be subject to the City Government.

Section 3. Annexation. That the property is hereby annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had been originally a part thereof.

Section 4. Zoning. The area above described shall be zoned R-2 Residents District.

Section 5. Effective Date. This ordinance shall be filed and shall take effect and be in full force and affect from and after the filing of a copy of this ordinance with the Minnesota Municipal Commission, the Willmar Town Clerk, the Kandiyohi County Auditor, and the Secretary of
