ORDINANCE NO. 536

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota, by the sole owners of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

All that part of the Northeast Quarter of the Southeast Quarter of Section 9, Township 111 North, Range 41 West, lying Northerly of the Trunk Highway No. 23 Right-of-Way and Westerly of the Chicago and Northwestern Railroad Right-of-Way and containing 15.2 acres, more or less.

Section 2. This quantity of land embraced within the foregoing description as bounded and described, is 15.2 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota, and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 4. Therefore, the City of Marshall, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same are hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if they had been originally a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Lake Marshall Township, the County Auditor of Lyon County and the Secretary of State, and from and after its passage and publication.

Passed and adopted by the Common Council this 4th day of March, 1974.

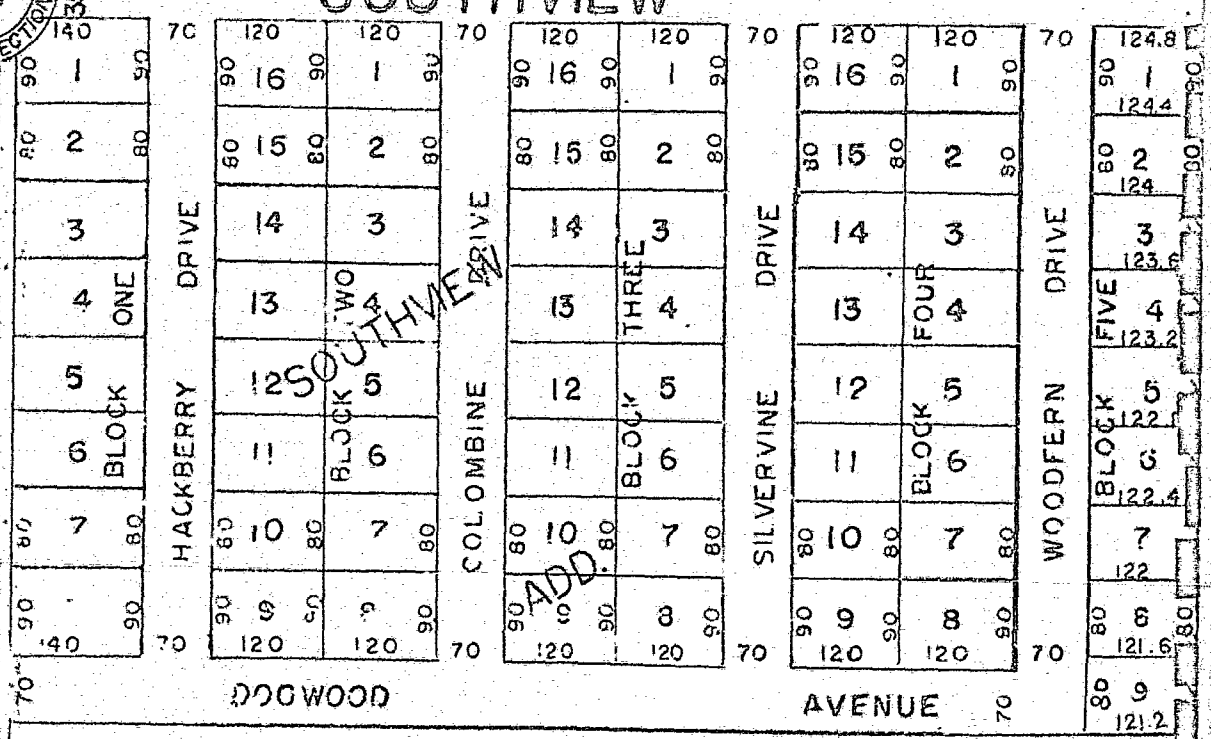

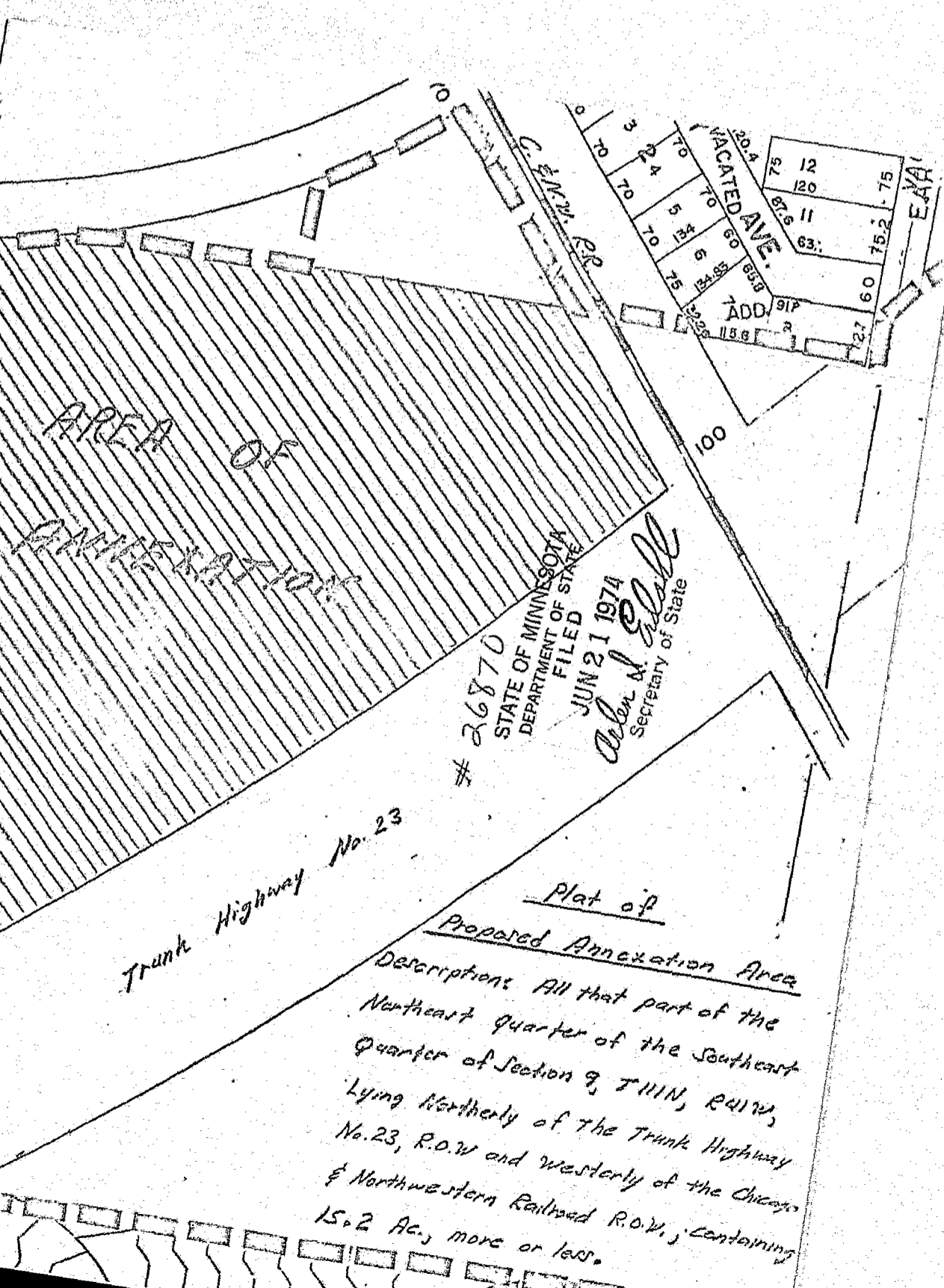

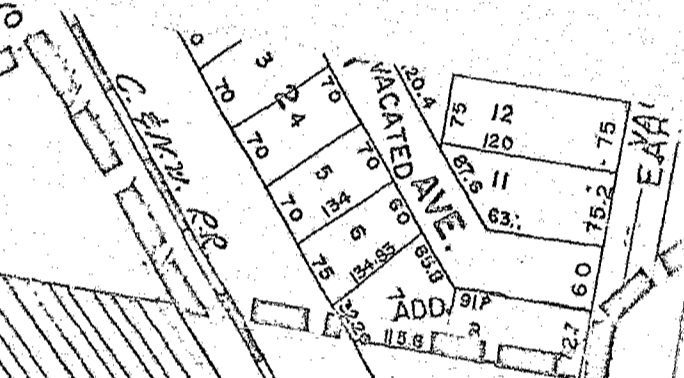
Existing Corporate City Limits
