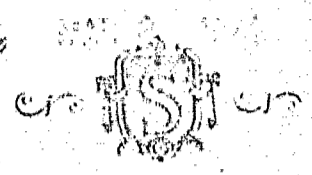

ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF STEWARTVILLE

WHEREAS, the land being annexed is owned by the City no Public Hearing is required;
AND WHEREAS, THE LAND IS ADJACENT TO THE City Limits;
AND WHEREAS, the City Council has determined that the annexation will be to the best interest of the City and territory affected;
THE CITY COUNCIL OF STEWARTVILLE, Minnesota does ordain;

1. The following lands are hereto annexed and made a part of the City of Stewartville, to-wit:

A tract of land lying in the E½ of the SE¼ of Section 27, Township 105 North, Range 14 West, Olmsted County, Minnesota, more particularly described as follows: Beginning at the southeast corner of said Section 27 marked by a one inch iron rod; thence North 89 degrees 45 minutes 30 seconds West, 936.68 feet along the South line of said Section 27 to the center line of the Chicago Greatwestern Railway; thence North 34 degrees 28 minutes 30 seconds East, 100.00 feet along the center line of railway; thence North 31 degrees 28 minutes 30 seconds East, 100.00 feet along center line of railway; thence North 28 degrees 28 minutes 30 seconds East, 100.00 feet along center line of said railway; thence North 25 degrees 24 minutes 30 seconds East, 100.00 feet along the center line of said railway; thence North 22 degrees 26 minutes 30 seconds East, 100.00 feet along the center line of said railway; thence North 19 degrees 17 minutes 30 seconds East, 100.00 feet along the center line of said railway; thence North 16 degrees 14 minutes 30 seconds East 100.00 feet along the center line of said railway; thence North 13 degrees 25 minutes 30 seconds East, 100.00 feet along the center line of said railway; thence North 10 degrees 24 minutes 30 seconds East, 162.58 feet along the center line of said railway; thence North 9 degrees 12 minutes 00 seconds East, 326.40 feet along the center line of said railway; thence South 73 degrees 33 minutes 30 seconds East, 551.69 feet to a point on the east line of Section 27; thence South 00 degrees 15 minutes 00 seconds East, 1055.90 feet along the East line of said Section 27 to the point of beginning, less the Westerly 50 feet there-of, and less a strip of land as described on pages 177 and 178 in deed record Book # 68, and subject to easement to the American Oil Co. for the right to lay, maintain, inspect, operate, replace change, or remove a pipe line for the transportation of oil. Gas or the products there-of over and across the above described tract of land, and other easements of record. Containing in all 15.9 acres. Bearings are assumed.

2. The City Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

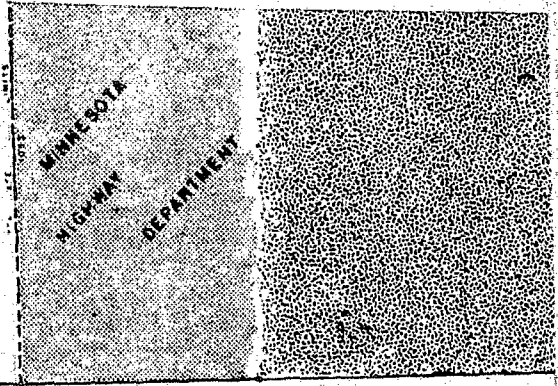
