ORDINANCE NO. 74-03

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINSTED TO INCLUDE CERTAIN UNINCORPORATED, UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated the 6<sup>th</sup> day of May, 1974, requesting annexation of the territory herein-after described, was duly presented to the Council on the 6<sup>th</sup> day of May, 1974, and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 16.74 acres of unplatted land, no part of which is included within the limits of an incorporated City, Village or Borough, and

WHEREAS, the Petition was signed by the sole owner of said land,

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or any governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City limits at the North boundary thereof; the Council of the City of Winsted, Minnesota, ordains:

Section 1. The City Council hereby determines that the annexation will be in the best interests of the City and of the territory affected; that the territory described abuts upon the city limits and is about to become urban or suburban in character; and that none of the said territory is now included within the limits of any City, Village or Borough.

Section 2. Territory Annexed. The corporate limits of the City of Winsted are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City of Winsted as effectually as if it had originally been a part thereof:

That part of the Southwest Quarter of the Northwest Quarter of Section 2, Township, 117 North, Range 27 West, McLeod County, Minnesota, described as follows: Commencing at the southeast corner of said Southwest Quarter of the Northwest of Section 2, thence on an assumed bearing of North 0 degrees 27 minutes 59 seconds West along the east line of said Southwest Quarter of the Northwest Quarter for a distance of 208.00 feet to the actual point of beginning of the tract to be described; thence continuing on a bearing of North 0 degrees 27 minutes 59 seconds West along the said east line of the Southwest Quarter of the Northwest Quarter for a distance of 800.125 feet to a point which lies South 0 degrees 27 minutes 59 seconds East, 313.062 feet from the north east corner of said Southwest Quarter of the Northwest Quarter; thence on a bearing of South 89 degrees 36 minutes 20 seconds West parallel with the north line of said Southwest Quarter of the Northwest Quarter for a distance of 110.433 feet to a point that is 313.062 feet East of the west line of said Southwest Quarter of the Northwest Quarter and 313.062 feet South of the said north line of Southwest Quarter of the Northwest Quarter; thence on a bearing of South 0 degrees 25 minutes 22 seconds East parallel with the said west line of Southwest Quarter of the Northwest Quarter for a distance of 524.936 feet to a point that is 417.416 feet North of the south line of said Southwest Quarter of the Northwest Quarter and 313.062 feet East of the said west line of the Southwest Quarter of the Northwest Quarter; thence on a bearing of East parallel with the said south line of the Southwest Quarter of the Northwest Quarter for a distance of 486.44 feet; thence on a bearing of South 0 degrees 25 minutes 22 seconds East parallel with the said west line of the Southwest Quarter of the Northwest Quarter for a distance of 417.416 feet to the said south line of the Southwest Quarter of the Northwest Quarter; thence on a bearing of East along the said south line of the Southwest Quarter of the Northwest Quarter for a distance of 103.71 feet; thence on a bearing of North 0 degrees 27 minutes 59 seconds West parallel with the said east line of the Southwest Quarter of the Northwest Quarter for a distance of 208.00 feet; thence on a bearing of East parallel with the said south line of the Southwest Quarter of the Northwest Quarter for a distance of 416.00 feet to the actual point of beginning.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this Ordinance with the Minnesota
