Commissioner's State Recreational Trail
Order No. 3 (Heartland)

Whereas the land within what was the former right-of-way of the Burlington Northern Inc. running generally from Park Rapids to Cass Lake, Minnesota, and more particularly starting at the south line of Section 24, Township 140 North, Range 35 West in Hubbard County and proceeding through Section 13 of Township 140 North, Range 35 West; Sections 18, 7, 8, 9, 10, 11 and 12 of Township 140 North, Range 34 West; Sections 7, 8, 9, 10, 3 and 2 of Township 140 North, Range 33 West; Sections 35 and 36 of Township 141 North, Range 33 West; Sections 31, 30, 29, 28, 27, 22, 23, 24, and 13 of Township 141 North, Range 32 West; all in Hubbard County and continuing at the west line of Section 18, Township 141 North, Range 31 West of Cass County and proceeding through Sections 7, 8, 5 and 4 of Township 141 North, Range 31 West; Sections 33, 28, and 27 of Township 142 North, Range 31 West; and terminating on the south side of the May Lake Road in the City of Walker in Section 22, Township 142 North, Range 31 West; and starting again on the south line of Section 9, Township 142 North, Range 31 West and proceeding through Sections 9, 4 and 5 of Township 142 North, Range 31 West; Sections 32, 29, 20, 21, 16, 9, 4, and 5 of Township 143 North, Range 31 West; Sections 32, 29, 20, 17, 8 and 5 of Township 144 North, Range 31 West; Sections 33 and 28 of Township 145 North, Range 31 West and terminating at a point 200 feet north of the south line of Section 21, Township 145 North, Range 31 West, all in Cass County; and further as posted with signs designating "State Trail", have been established by the Legislature as a State Recreational Trail in Minnesota Statutes § 85.015, Subd. 12;

And whereas the most effective means by which such lands can be developed and protected for recreational purposes for future generations is by designation as a state recreational trail;

And whereas said lands have been sufficiently developed for such uses and have acquired a need for protection;

Now, therefore, I, Robert L. Herbst, Commissioner of the Department of Natural Resources, pursuant to authority vested in me by law, do hereby designate the above described lands as the Heartland Trail.


It is further ordered that the provisions of NR 20 apply to the use of the above designated area.


