ORDINANCE NO. 53

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO  
AND EXTENDING THE CORPORATE LIMITS OF THE  
CITY OF FAIRMONT, MINNESOTA, AND PROVIDING  
FOR THE ZONING THEREOF

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY  
OF FAIRMONT, MINNESOTA, AS FOLLOWS:

Section 1. That the property hereinafter described abutts upon the corporate limits of the City of Fairmont, Minnesota and the perimeter of the area to be annexed is sixty percent or more bordered by the City of Fairmont, Minnesota; that notice of City of Fairmont's intent to annex was served upon the chairman of the Rolling Green Township Board on the 17th day of October, 1975; that it will be to the best interest of the municipality and the territory affected to annex said territory; that said property is urban in character and subject to annexation pursuant to M.S.A. Sec. 414.033, subd. 3.

Section 2. That said property is located in the County of Martin, State of Minnesota, and described as follows, to-wit:

A tract of land in the Southeast Quarter of Section 1 in Township 102 North of Range 31 West of the Fifth Principal Meridian in Martin County, Minnesota described as follows: Commencing at the Southeast corner of the Southeast Quarter of Section 1, T102N, R31W, thence West along the South line of the said Southeast Quarter of Section 1 for a distance of 1192.2 feet to the point of beginning, thence North at a deflection angle of 90°00' with the said South line of Section 1 for a distance of 545.6 feet, thence West for a distance of 400.0 feet on a line parallel with the North right-of-way line of Minnesota Trunk Highway No. 16, thence South for a distance of 545.8 feet to a point on the South line of the Southeast Quarter of Section 1, thence East along the said South line of Section 1 for a distance of 400.0 feet to the point of beginning.




