AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED UNPLATTED LAND ABUTTING UPON THE CITY LIMITS OF THE CITY OF NEW YORK MILLS AND EXTENDING THE CORPORATE LIMITS OF THE CITY OF NEW YORK MILLS TO INCLUDE THE SAME.

The City Council of the City of New York Mills, Minnesota do ordain as follows:

Section 1. The City Council hereby determines (1) that annexation of the hereinafter described territory will be in the best interests of the city and of the territory affected; (2) that the hereinafter described territory abuts upon the city limits and is about to become urban in character through the construction of an apartment complex thereon; (3) that none of said territory abuts upon or is included within the limits of any other city; and (4) all of the owners of any interest in said territory have petitioned this council for the annexation of said territory by the City of New York Mills and for extending the corporate limits of the City of New York Mills to include the same.

Section 2. Territory annexed. The corporate limits of the City of New York Mills are hereby extended to include the unplatted land described as follows:

The East 825 feet of the North 264 feet of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section 17, Township 135, Range 37,

and the same is hereby annexed to and included within the City of New York Mills as effectively as if it had originally been a part thereof.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Town Clerk of the Town of Newton, the County Auditor of the County of Otter Tail and the Secretary of State of the State of Minnesota.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and upon the filing of the certified copies as directed in Section 3.
