ORDINANCE NO. 165

AN ORDINANCE ANNEXING TERRITORY AND EXTENDING CITY LIMITS,  
AND REPEALING ORDINANCE NO. 122.

THE CITY COUNCIL OF THE CITY OF DAWSON, MINNESOTA DOES HEREBY ORDAIN

THE FOLLOWING:

SECTION 1: This ordinance repeals Ordinance 122.

SECTION 2: That it is hereby found and determined that that tract of  
land situated in Lac Qui Parle County, Minnesota, described as follows, to-wit:

All that part of the Southwest Quarter of the Northeast Quarter  
(SW $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Section Twenty (20), Township One Hundred Seventeen  
North (117 N), Range Forty-Three West (43 W), described as follows:  
Beginning at the Southeast corner of said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ ; thence  
North along the East line of said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , 1357.05 feet;  
thence West along the north line of said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , a distance  
of 350.0 feet; then South, parallel to the East line of said SW $\frac{1}{4}$   
of the NE $\frac{1}{4}$  a distance of 670 feet; thence on a bearing of S 12°07'  
30" W, 243.94 feet; thence South, parallel to the East line of said  
SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  a distance of 213.57 feet; thence on a bearing of  
S 68°44'37" W, 32.49 feet; thence south, parallel to the East line  
of said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ , a distance of 223.21 feet to the South line  
of said SW $\frac{1}{4}$  of the NE $\frac{1}{4}$ ; thence East along said line,  
425 feet to the point of beginning, and containing 10.00 acres more  
or less,

abuts on and is immediately adjacent to the westerly limits of the City of  
Dawson, Minnesota, and is presently agricultural land but is suitable and  
adaptable to residential development, and that it is to the best interests of  
the City of Dawson and of said above described territory that it be annexed to  
the City of Dawson for all government purposes.

SECTION 3: That it is also hereby found and determined that the  
petition of the owners of said property, praying for such annexation, was duly  
filed with the City of Dawson, the Town of Riverside, the County of Lac Qui Parle,  
and with the Minnesota Municipal Commission, pursuant to the provisions of  
Section 414.033, Subdivision 5, of Minnesota Statutes Annotated, and that no  
objections thereto have been presented or filed.

SECTION 4: That all of said tract described in SECTION 2 hereof is  
hereby annexed to the City of Dawson, Minnesota for all governmental purposes and  
that the city limits of the City of Dawson are hereby extended and enlarged to  
include the same, and that all thereof is hereby zoned as residential district  
property and is assigned to and made a part of the Third Ward of Dawson.

SECTION 5: That this ordinance shall be in effect from and after final

passage and publication and that true and correct copies thereof to be forwarded to and filed with Minnesota Municipal Commission, the County Auditor of Lac Qui Parle County, Minnesota, and the Secretary of State of the State of Minnesota.
