

AMENDMENT TO THE CITY CHARTER, Chapter 1, Section 1.

THE CITY COUNCIL OF THE CITY OF SPRINGFIELD, ILLINOIS, DOETH ORDER:

That City Charter, Chapter 1, Section 1, which now reads:

Section 11. - DISBURSEMENTS: All disbursements shall be made only upon the order of the mayor and city clerk duly authorized by a motion of the council, and every such order shall specify the purpose for which the disbursement is made, and indicate that it is to be paid out of the proper fund. Each such order shall be directed to the city treasurer, and the latter shall pay the sum if there is sufficient money in that particular fund with which to pay it. If no money is in such fund, the city treasurer shall make out same "not paid for want of funds" with date of such endorsement and such warrant shall draw legal rate of interest from date of such endorsement. The city treasurer shall keep record of such endorsements and pay such warrants as soon as there is money in that particular fund, accordingly as they are filed. The city treasurer shall make no payment out of any fund except upon orders issued by the city council and signed by the city mayor and city clerk. Any order or resolution for the payment of money violating any provisions of this section shall be void, and any officer of the city violating any provision of this section shall be personally responsible for the amount of such payment, if any such payment is made contrary to the provisions hereof. No contract requiring the payment of money by the city shall be valid unless the particular fund out of which the sum is to be paid is specified in such contract. No claim against the city shall be allowed unless accompanied by an itemized statement and voucher signed to, payroll or time sheet signed by the responsible officer who has personal knowledge of the facts in the case and vouchers for the correctness and reasonableness of the claim. The council may by ordinance make further regulations for the keeping and disbursement of the city's fund.

Shall be amended to read as follows:

Section 11. - DISBURSEMENTS:

(A) All disbursements, except the Hospital Board disbursements, shall be made only upon the order of the mayor and city clerk duly authorized by a motion of the council, and every such order shall specify the purpose for which the disbursement is made, and indicate that it is to be paid out of the proper fund. Each such order shall be directed to the city treasurer, and the latter shall pay the sum if there is sufficient money in that particular fund with which to pay it. If no money is in such fund, the city treasurer shall endorse same "not paid for want of funds" with date of such endorsement and such warrant shall draw legal rate of interest from date of such endorsement. The city treasurer shall keep record of such endorsements and pay such warrants as soon as there is money in that particular fund accordingly as they are filed. The city treasurer shall make no payment out of any fund except upon orders issued by the city council and signed by the city mayor and city clerk. Any order or resolution for the payment of money violating any provisions of this section shall be void, and any officer of the city violating any provision of this section shall be personally responsible for the amount of such payment, if any such payment is made contrary to the provisions hereof. No contract requiring the payment of money by

the city shall be valid unless the particular fund out of which the same is to be paid is specified in such contract. No claim against the city shall be allowed unless accompanied by an itemized statement, payroll or time sheet signed by the responsible officer who has personal knowledge of the facts in the case of the correctness and reasonableness of the claim. The council may by ordinance make further regulations for the safekeeping and disbursement of the city's fund.

- (3) All hospital fund disbursements may be made upon the same verification as set out above except that payment can be made upon the order of the Hospital Administrator, one member of the Executive Committee of the Hospital Board, and the City Treasurer.
