
WHEREAS, the Honorable Clifford E. Olson,

division 12, and 490.124, Subdivision 4, and


WHEREAS, the said Judge Clifford E. Olson has

close of business on July 31, 1977. He shall become entitled  
thereafter to retirement compensation as provided under the  
law, and I further direct that this Order be filed
