REORGANIZATION ORDER NUMBER 81

Pursuant to Minnesota Statutes 1976, Section 16.125, 16.13 and 16.135, the following administrative reorganization is made.

The existing responsibilities of the CETA Coordinator in the Department of Administration (DOA) to negotiate and administer contracts with CETA prime sponsors for state agency CETA positions will be expanded and will be carried out by the CETA Division, DOA.

In order to expedite the necessary CETA Administrative work and promote economy and efficiency CETA Division will perform centrally all CETA accounting work, including preparation of reimbursement requests, and storage of data on use of CETA positions and report preparation.
