**ORDINANCE NO. 175**

**AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE CITY OF LE ROY, MINNESOTA:**

WHEREAS, all the owners of the premises hereinafter described have petitioned the City Council that said premises be annexed to the corporate limits of the City of LeRoy, Minnesota and that said premises are contiguous to and adjoining the City of LeRoy, and subject to incorporation within the corporate limits of LeRoy, Minnesota, by petition to the governing body of the City of LeRoy;

AND WHEREAS, due notice has been given to the Township of LeRoy, Commissioners of Mower County and the Municipal Commission of the State of Minnesota:

NOW THEREFORE, the City Council of the City of LeRoy, Mower County, Minnesota do ordain:

Section 1. The land hereinafter described shall be added to and incorporated within the corporate limits of the City of LeRoy, and said City Council does hereby declare said premises hereinafter described to be incorporated within and to be a part of the City of LeRoy, described as follows:

Beginning at a point 153.97 feet south of the NE corner of Hickok Addition to the Village of LeRoy, Minnesota; thence southerly 692.03 feet on east line of said Hickok addition and said line extended; thence easterly 430 feet on a line parallel with the southerly line of said Hickok Addition; thence northerly 575 feet on a line parallel with the east line of said Addition; thence northwesterly 445.85 feet more or less, to the point of beginning; being part of the NW $\frac{1}{4}$  NE $\frac{1}{4}$  Sec. 34—T101N—R14W, and containing 6.24 acres.

Section 2. This Ordinance shall be in full force and effect from and after its passage and publication.
