ORDINANCE NO. 24

AN ORDINANCE DECLARING CERTAIN LAND
WHOLLY OWNED BY THE CITY OF
NORTH MANKATO TO BE ANNEXED
TO THE CITY OF NORTH MANKATO

The Common Council of the City of North Mankato does ordain
as follows:


Section 1. That the following described property, being no longer a part of a trunk highway and all right, title and interest of the State of Minnesota therein having reverted to the City of North Mankato pursuant to Minnesota Statute 161.16, Subdivision 4, and a perpetual easement over and across said property being wholly owned by the City of North Mankato, be and hereby is annexed and declared to be part of the City of North Mankato pursuant to Minnesota Statute 414.033, Subdivision 2:

Beginning at the intersection of Trunk Highway 14 and the East-West centerline of Section 10 (centerline of Lee Boulevard), Township 108 North, Range 27 West, Nicollet County, Minnesota and designated as station 664+17.2 on Minnesota Department of Transportation (MHD) drawing of "Right-of-Way Map - Nicollet County between North Mankato and 4 miles Northwest" new project designation S.P. 5203 (T.H. 14=122); thence northwesterly and including 75.00 feet on each side of the existing centerline of Trunk Highway 14 (Lookout Drive) approximately 2192.5 feet to the limit of the turnback from Minnesota Department of Transportation to the City of North Mankato.

Section 2. This Ordinance shall take effect from and after its date of passage and publication.
