ORDINANCE 114

WHEREAS, the Townships of Cairo and Camp, the owners of the following described land, requested the City of Fairfax to annex said land; the City of Fairfax, on November 2, 1976, executed a Resolution requesting the Minnesota Municipal Board to annex said land to the City of Fairfax; and the Town Boards of the Townships of Cairo and Camp have stated that they have no objections to the annexation of said land to the City of Fairfax by Waivers dated November 10, 1976; and

WHEREAS, the City Council of the City of Fairfax has determined that the annexation of said land will be to the best interests of the City of Fairfax and of the land itself, in that the maintenance of the road crossing said land is necessary for access to city property which abuts it, and in that the annexation of said land will permit the City of Fairfax to maintain the road lying on said land;

NOW THEREFORE, the City Council of the City of Fairfax, County of Renville, State of Minnesota, does ordain and declare:

That the following described land is hereby annexed to the City of Fairfax, to-wit:

That portion of the public road as now established, known as the Camp Township Road, from its junction with the south boundary line of that duly dedicated highway known and numbered as Minnesota State Highway 19, thence southerly to the south line of the following described property which is within the corporate limits of the annexing municipality, to-wit:

Lot B in the North Half of the Northwest Quarter (N $\frac{1}{2}$ of NW $\frac{1}{4}$) of Section Seven (7) in Township One Hundred Twelve (112) North, Range Thirty-two (32) West, and the North Two Hundred Seventy-three Feet (N-273') of the South Half of the Northwest Quarter (S $\frac{1}{2}$ of NW $\frac{1}{4}$) of Section Seven (7) in Township One Hundred Twelve (112) North, Range Thirty-two (32) West.

Said road running North and South between the Townships of Cairo and Camp.
