AMENDED ORDER

On February 13, 1978, the Municipal Board issued an order annexing an area within Lake View Township to the City of Detroit Lakes. The Board's decision included findings which, through clerical error, were not recorded accurately in the final order. The correct findings made by the Board in making their decision are as follows:

FINDINGS OF FACT

- 4. Geographic Features
 - b. The total area of the City of Detroit Lakes is 3.07 square miles. The total area of the territory subject to annexation is ¹²²~~116~~ acres.

PROPERTY DESCRIPTION

The attached letter and attachment set forth an amended property description as well as the reasons for said amendment. The amended description shall be substituted for the property description in FINDINGS OF FACT 2. on page -1- of the order and the property description in the ORDER contained on page -5- of the February 13th order.

Dear Mr. Neiman:

In reviewing the Minnesota Municipal Board's Annexation Order of February 13, 1978, annexing certain lands to the City of Detroit Lakes, it was discovered that the description of the area to be annexed contained some erroneous and nonsense language which should be removed from the description. The language is obviously an error and if one traced out on the map the way line 21 and part of line 22 state, one would find himself going in a direction that is not possible. By deleting line 21 and part of line 22, the description corrects itself. In no way will the deletion of line 21 and part of line 22 add to or detract from the original area requested to be annexed.

I have enclosed a copy of the description as reviewed by our City Engineer, which also computes the acreage to be 122 acres. You will note that the description is initialed by R.F.P. (Robert F. Peterson), dated February 10, 1978. Mr. Peterson is the City Engineer for the City of Detroit Lakes.

Please refer to my letter of transmittal, dated July 9, 1976, which states that the area to be annexed consists of approximately 122 acres.

We are indeed sorry for any inconvenience this description error may cause, but please be assured that the description correction in no way changes the area to be annexed. It merely eliminates superfluous or nonsense language.
