ORDINANCE NO. 19 , 2ND SERIES

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY
OF THIEF RIVER FALLS

THE CITY COUNCIL OF THIEF RIVER FALLS, MINNESOTA, ORDAINS:

Section 1. WHEREAS, the sole owners of the following described premises situated in the County of Pennington and State of Minnesota, to-wit:

A parcel of land which is part of Govt. Lots Nine (9) Ten (10), Eleven (11) and Twelve (12) of Section Thirty-five (35), Township One Hundred Fifty-four (154) North, Range Forty-three (43) West, bounded as follows:

Beginning at a point on the North line of Greenwood Street extended which point lies 744.8 feet Westerly of the Southwest corner of Lot 1, Block 4, Nelson's First Addition to Thief River Falls; thence from said point of beginning N 24° 54' 49" E a distance of 220 feet; thence N 41° 46' 11" W a distance of 435.75 feet; thence N 48° 13' 49" E a distance of 396.4 feet more or less to the centerline of Nelson Drive; thence Northwesterly along said centerline a distance of 1827.0 feet to the Northwesterly line of said Nelson Drive; thence S 15° 38' 00" W along said Northwesterly line a distance of 89.598 feet; thence S 56° 14' 00" W along said Northwesterly line a distance of 603.8 feet; thence S 41° 37' 55" E a distance of 560 feet more or less to the Northwesterly line of Barnick's First Addition; thence N 48° 22' 05" E a distance of 200 feet along said Northwesterly line; thence S 41° 37' 55" W along the Northeasterly line of Barnick's Addition a distance of 996.647 feet; thence N 48° 22' 05" E a distance of 100 feet; thence S 41° 37' 55" W a distance of 591.118 feet to the South line of said Section 35; thence S 86° 31' 55" E along said South line a distance of 300.233 feet; thence N 03° 28' 05" E a distance of 56 feet to the point of beginning; containing 40.3 acres more or less,

have petitioned to the City Council to have such land included within the City Limits of the City of Thief River Falls and have filed copies of said Petition with the Municipal Board of the State of Minnesota, with the Town Board of the Township of North of the County of Pennington and State of Minnesota and with the County Board of the County of Pennington, State of Minnesota, and

WHEREAS, the above described property abuts upon the

boundaries of the City of Thief River Falls, and

WHEREAS, no objections to the proposed annexation have been submitted,

NOW, THEREFORE, It is hereby determined that the annexation of said premises will be to the best interests of the City of Thief River Falls.

Section 2. City Code Chapter 20, Listing of Uncoded Annexation Ordinances is hereby amended by addition of the foregoing ordinance to such listing.

Section 3. This ordinance shall be in force and effect from and after its passage, approval, publication and filing with the Municipal Board, the Town Clerk of North Township, the Pennington County Auditor and the Secretary of State of the State of Minnesota.
