ORDINANCE NO. 1320

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough:

WHEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the City and is deemed to be urban in character;

THE COMMON COUNCIL OF THE CITY OF AUSTIN HEREBY ORDAINS:

SECTION 1: Territory annexed. The corporate limits of the City of Austin, Minnesota, are hereby extended to include the territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Lots 4, 5, & 6 of Block 2, Lots 13, 14, 15, & 16 of Block 4 Nob Hill Addition including all of the street right of way adjacent to these lots.

SECTION 2: Filing. The City Recorder is directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Township Clerk, County Auditor, Registrar of Deeds, Austin Utilities, and the Secretary of State.

SECTION 3: Effective date of Annexation. This Ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.
