ORDINANCE NO. 503

AN ORDINANCE ANNEXING TO THE CITY OF  
KASSON, MINNESOTA CERTAIN LAND IN  
MANTORVILLE TOWNSHIP, SECTION 28,  
TOWNSHIP 107 NORTH, RANGE 16  
DODGE COUNTY, MINNESOTA

THE CITY COUNCIL OF THE CITY OF KASSON DO ORDAIN:

Section 1. The following described land in Mantorville Township, Dodge County, Minnesota, is owned by and abuts the municipal limits of the City of Kasson:

Commencing at a point 300 feet West of the Southeast corner of Southwest Quarter (SW $\frac{1}{4}$ ) Section 28, Township 107, Range 16, thence running West 690 feet to a point, thence running North 132 feet to a point, thence running South 132 feet to the place of beginning, containing 2.09 acres, more or less.

and

Commencing at a point 132 feet North and 300 feet West of the Southeast corner of Southwest Quarter (SW $\frac{1}{4}$ ) Section 28, Township 107, Range 16, thence West 360 feet to a point, thence North 99 feet, thence East 360 feet, thence South 99 feet to place of beginning, containing .82 acre, more or less.

and

Commencing at the Southeast corner of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section 28, Township 107, Range 16, thence East 20 rods, thence North 8 rods, thence East 20 rods, thence North 22 rods, thence West 40 rods, thence South 30 rods to place of beginning, containing 6.50 acres, more or less.

Section 2. Pursuant to Minnesota Statutes 1976, section 414.033, subd. 2, as amended, the land described in section 1 above comprising approximately 9.41 acres is hereby annexed, added to and made a part of the City of Kasson, Minnesota.

Section 3. This ordinance shall take effect and be in force from and after its official publication and from and after the filing of a certified copy hereof with the Minnesota Municipal Commission, the Mantorville Town Clerk, The County Auditor and the Secretary of State.
