
ORDINANCE NO. 396  
AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE  
CITY OF MORRIS

THE COUNCIL OF THE CITY OF MORRIS DOES HEREBY ORDAIN:

SECTION 1. That the following described real estate be and hereby is annexed to the corporate limits of the City of Morris:

Commencing at the Southeast corner of said Section 2; thence along the South line of said Southeast quarter on an assumed bearing of North 88 degrees, 40 minutes, 20 second West, a distance of 1390.94 feet, to the intersection with a Westerly right-of-way line of State Trunk Highway No. 59 as shown on State Highway Right-of-Way Plat No. 75-3 and filed in the office of the County Recorder as Document No. 117793, and being the point of beginning, of tract to be described; thence continuing North 88 degrees, 40 minutes, 20 seconds West, 53.40 feet; thence North 42 degrees, 48 minutes, 59 seconds East, on a line 40 feet Northwesterly of, and as measured at right angles to, said Westerly right-of-way line, a distance of 215.43 feet; thence North 01 degrees, 24 minutes, 57 seconds East 441.83 feet; thence North 02 degrees, 26 minutes, 05 seconds East, 300.13 feet; thence North 04 degrees, 01 minutes, 09 seconds East a distance of 200.08 feet, more or less to a point which is 9.0 feet East of, and located on, the Easterly extension of the South line of said plat of Elles Addition as monumented in the field; thence North 89 degrees, 09 minutes, 29 seconds West along said extended line and along the Southerly line of said Elles Addition, a distance of 119.95 feet to the Southwest corner of Lot 18, Block 2, Elles Addition; thence North 01 degrees, 0 minutes, 24 seconds East, along the West line of said Block 2, a distance of 304.97 feet; thence South 89 degrees, 03 minutes, 0 seconds East, 420 feet; thence South 01 degrees, 02 minutes, 24 seconds West, 948.20 feet more or less, to said Westerly right-of-way line of Highway 59; thence South 42 degrees, 48 minutes, 59 seconds, West along said right-of-way line, 616.31 feet, more or less to the point of beginning. Excepting therefrom any portion lying within the Elles University Addition to the City of Morris, Stevens County, Minnesota, Subject to an easement over the South 50 feet thereof for County State Aid Highway No. 10. This contains 8.24 acres more or less.

THE COUNCIL OF THE CITY OF MORRIS DOES HEREBY ORDAIN:

SECTION 1. That the following described real estate be and hereby is annexed to the corporate limits of the City of Morris:

Commencing at the Southeast corner of said Section 2; thence along the South line of said Southeast quarter on an assumed bearing of North 88 degrees, 40 minutes, 20 second West, a distance of 1390.94 feet, to the intersection with a Westerly right-of-way line of State Trunk Highway No. 59 as shown on State Highway Right-of-Way Plat No. 75-3 and filed in the office of the County Recorder as Document No. 117793, and being the point of beginning, of tract to be described; thence continuing North 88 degrees, 40 minutes, 20 seconds West, 53.40 feet; thence North 42 degrees, 48 minutes, 59 seconds East, on a line 40 feet Northwesterly of, and as measured at right angles to, said Westerly right-of-way line, a distance of 215.43 feet; thence North 01 degrees, 24 minutes, 57 seconds East 441.83 feet; thence North 02 degrees, 26 minutes, 05 seconds East, 300.13 feet; thence North 04 degrees, 01 minutes, 09 seconds East a distance of 200.08 feet, more or less to a point which is 9.0 feet East of, and located on, the Easterly extension of the South line of said plat of Elles Addition as monumented in the field; thence North 89 degrees, 09 minutes, 29 seconds West along said extended line and along the Southerly line of said Elles Addition, a distance of 119.95 feet to the Southwest corner of Lot 18, Block 2, Elles Addition; thence North 01 degrees, 0 minutes, 24 seconds East, along the West line of said Block 2, a distance of 304.97 feet; thence South 89 degrees, 03 minutes, 0 seconds East, 420 feet; thence South 01 degrees, 02 minutes, 24 seconds West, 948.20 feet more or less, to said Westerly right-of-way line of Highway 59; thence South 42 degrees, 48 minutes, 59 seconds, West along said right-of-way line, 616.31 feet, more or less to the point of beginning. Excepting therefrom any portion lying within the Elles University Addition to the City of Morris, Stevens County, Minnesota, Subject to an easement over the South 50 feet thereof for County State Aid Highway No. 10. This contains 8.24 acres more or less.
