ORDINANCE NO. 79-1

AN ORDINANCE TO ANNEX TO THE CITY  
OF ALVARADO CERTAIN UNPLATTED LANDS  
OWNED BY HAROLD J. ERICKSON AND  
ALOIS ERICKSON.

The City Council of the City of Alvarado, Alvarado, Minnesota, ordains  
as follows:

Section 1. That Harold J. Erickson and Alois Erickson are the sole  
owners of certain real estate located in Marshall County, Minnesota,  
and legally described as follows:

All that part of the Southeast Quarter of the Northeast  
Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Six (6), Township One Hun-  
dred Fifty-four (154) North of Range Forty-nine (49)  
West of the Fifth Principal Meridian, which lies east  
of the Snake River, excepting therefrom that part thereof  
which lies north of a line lying parallel with and 1035.00  
feet south of the north line of said Southeast Quarter of  
the Northeast Quarter of Section Six (6) and also excepting  
therefrom the east 75 feet thereof.

Section 2. That Harold J. Erickson and Alois Erickson have filed a  
petition with the City of Alvarado asking that the City of Alvarado annex  
the above described property to the City of Alvarado.

Section 3. That said land is unplatted and does not exceed 200 acres.

Section 4. That said land abuts the City of Alvarado and is urban in  
character.


Section 5. That the annexation of said real estate is in the best interest

real estate.

Section 6. The City of Alvarado hereby ordains and declares that the real  
estate described in Section 1 hereof be and the same hereby is annexed to  
and included in the City of Alvarado, Alvarado, Minnesota, as effectively  
as if it had originally been a part thereof.


Section 7. This ordinance shall be final and shall be effective upon its

of State.


