## LEGAL NOTICES

ORDINANCE NO. 264

CITY OF ADRIAN,  
NOBLES COUNTY, MINNESOTA

AN ORDINANCE ANNEXING  
TERRITORY TO THE CITY OF  
ADRIAN.

WHEREAS, The tract of land hereinafter described is unplatted, abuts on the City of Adrian, and is not included in any other municipality;

AND WHEREAS, All owners of such tract hereinafter described have heretofore petitioned the City Council to have such land included within the City of Adrian;

AND WHEREAS, The City Council finds and determines that the annexation of the above property will be in the best interests of the public, of the City of Adrian and of said territory;

AND WHEREAS, The annexation of such territory under the above circumstances is authorized by Minnesota Statutes, Section 414.033, Subd. 5;

AND WHEREAS, The Township of Olney, Nobles County, Minnesota, has consented to the annexation and waived public hearing and any waiting period;

AND WHEREAS, All required filings with public bodies have been effected and that no public hearing with respect to annexation is required by law;

NOW, THEREFORE, Be it ordained by the City Council of the City of Adrian, as follows:

SECTION 1. The following described tract of land is hereby annexed to the City of Adrian:

A tract of land in the Southeast Quarter of the Northeast Quarter and in the Northeast Quarter of the Southeast Quarter of Section 18, Township 102 North, Range 42, West of the Fifth Principal Meridian in Nobles County, Minnesota; described as follows:

Commencing at the Southeast corner of said Section 18; thence on an assumed bearing of North along the easterly line of said Section a distance of 1474.98 feet to a point on the centerline of Nobles County road number 35 (old Minnesota Highway number 16); said point being the point of beginning of the tract to be described; thence North 80 degrees 21 minutes 00 seconds West along said centerline to a point on the westerly line of the Northeast Quarter of the Southeast Quarter and of the Southeast Quarter of the Southeast Quarter of the Northeast Quarter of said Section 18; thence North 0 degrees 22 minutes 28 seconds East along said westerly line to a point on the southwesterly right-of-way line of U.S. Interstate 90; thence southeasterly along said right-of-way line to a point on the easterly line of said Northeast Quarter of said Section 18; thence South 0 degrees 05 minutes 43 seconds East along said easterly line of said Northeast Quarter to the east quarter corner of said Section 18; thence South along the easterly line of the Southeast Quarter of said Section 18 a distance of 1196.95 feet to the point of beginning of the tract herein described.

Said premises are contiguous to the city limits of Adrian, Minnesota.

SECTION 2. This ordinance shall be effective upon its passage and publication, and upon filing a copy thereof with the Minnesota Municipal Commission, the Auditor of Nobles County, The Minnesota Secretary of State and the Town Clerk of Olney Township, Nobles County, Minnesota.


