ORDINANCE NO. 105

AN ORDINANCE ANNEXING LANDS TO THE
CITY OF ZUMBROTA

THE CITY COUNCIL OF ZUMBROTA ORDAINS:

That pursuant to Minnesota Statutes Section 414-033, Subd. 5,
the following described premises are hereby annexed to and
incorporated within the City of Zumbrota, to-wit:

Part of the Northwest Quarter (NW $\frac{1}{4}$) of the Northeast
Quarter (NE $\frac{1}{4}$) and the East Half (E $\frac{1}{2}$) of the Northwest
Quarter (NW $\frac{1}{4}$), all in Section 6, Township 109 North,
Range 15 West, in Goodhue County, Minnesota, described
as follows:

Commencing at a point on the southerly right-
of-way line of Old Trunk Highway No. 52 which is 167.00
feet northwesterly (measured along said right-of-way
line) from the northwesterly corner of Outlot "A" of
Anderson Addition, Goodhue County, Minnesota; thence
South 16 degrees 40'09" West 466.41 feet; thence
South 43 degrees 25'30" West 226.27 feet; thence
South 34 degrees 27'06" East 167.00 feet to the south-
westerly corner of Outlot "A" of said Anderson Addition;
thence South 55 degrees 32'54" West 528.38 feet; thence
South 38 degrees 47'07" West 343.08 feet to the northerly
right-of-way line of New Trunk Highway No. 52; thence
northwesterly along said right-of-way line to the west
line of the Northeast Quarter (NE $\frac{1}{4}$) of the Northwest
Quarter (NW $\frac{1}{4}$) of Section 6, Township 109 North, Range
15 West; thence north along said west line to the north-
west corner of the Northeast Quarter (NE $\frac{1}{4}$) of the North-
west Quarter (NW $\frac{1}{4}$) of said Section 6; thence east along
the north line of the Northeast Quarter (NE $\frac{1}{4}$) of the
Northwest Quarter (NW $\frac{1}{4}$) of said Section 6 to its inter-
section with the southerly right-of-way line of Old
Trunk Highway No. 52; thence southeasterly along said
southerly right-of-way line to the point of beginning.
(Containing approximately 43 1/2 acres).


