A RESOLUTION REQUESTING DISSOLUTION
OF REGION 10

WHEREAS, the Minnesota Regional Development Commission Act was established to provide a system of sub-state regions; and

WHEREAS, the sub-state regions were to provide coordinative A-95 services for the governmental units within their areas; and

WHEREAS, Region 10 has been established and is providing the A-95 services; and

WHEREAS, the State of Minnesota has enacted legislation which allows for governmental units to petition the State Planning Agency by formal resolution for termination of commission; and

WHEREAS, the Albert Lea City Council feels that the Southeastern Minnesota Regional Development Commission is not providing any valuable service to our community; and

WHEREAS, the Albert Lea City Council feels that the Southeastern Minnesota Regional Development Commission is no longer in the public welfare and interest and is not needed to accomplish the purpose of the Regional Development Act of 1969; now, therefore,

THE CITY OF ALBERT LEA DOES RESOLVE:

Sec. 1. That the Albert Lea City Council hereby petitions the State Planning Agency by resolution to hold hearings on the termination of the Southeastern Minnesota Regional Development Commission.

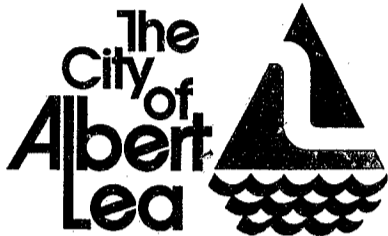
