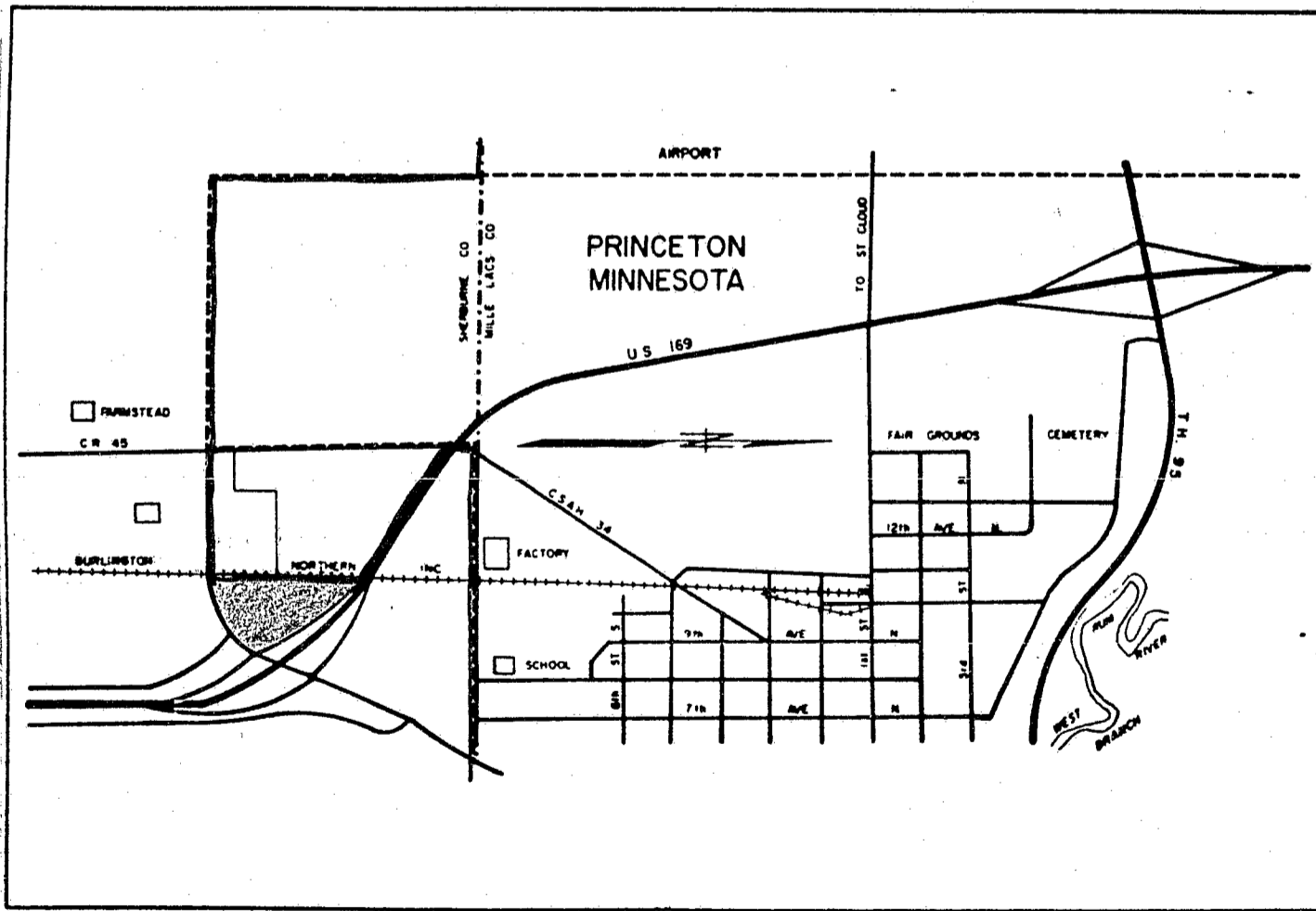

ORDINANCE NO. 315

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF PRINCETON
TO CERTAIN UNINCORPORATED UNPLATTED LAND OWNED BY THE
CITY OF PRINCETON ABUTTING UPON THE CITY LIMITS

* * * * *

WHEREAS, in furtherance of Development District No. 1 in the City of Princeton, it is found to be in the public purpose to acquire, annex and provide utilities to certain land abutting upon the City limits for the relocation of displaced businesses from said Development District No. 1, and

WHEREAS, The City did on October 21, 1981, acquire title to said land for the purpose of orderly development in accordance with the City's comprehensive plan; and

WHEREAS, no objections to the annexation have been received from the Town Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and

WHEREAS, the land acquired abuts upon the city limits at the Southeastern boundary thereof;

The Council of the City of Princeton, Minnesota, does hereby ordain:

Section 1. The City Council hereby determines (1) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; (2) that none of the territory is now included within the limits in order to protect the public health, safety and welfare of the City of Princeton; and (4) the annexation of said territory is in the best interest of the City of Princeton and the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed and included within the City of Princeton as effectually as if it had originally been a part thereof:

All that part of the Northwest Quarter, Section 4, Township 35, Range 26, Sherburne County, Minnesota lying East of the East line of the right-of-way of the Burlington Northern, Inc. (formerly Great Northern) railway, and lying Northerly, Northwesterly, Westerly, and Southwesterly of the right-of-way of Trunk Highway No. 169 as now located and established, said right-of-way being more particularly described as the line connecting Department of Transportation right-of-way monuments B-20 through B-28 inclusive as shown on the duly recorded State Highway Right-of-Way Plat No. 71-2. Excepting therefrom all that part thereof described as commencing at the Southwest corner of said Northwest Quarter of Section 4; thence North 89°01'24" East, assumed bearing, along the South line of said Northwest Quarter for a distance of 1172.81 feet to intersect said Easterly line of the railroad right-of-way; thence North 1°57'34" East along said Easterly line of the railroad right-of-way a distance of 140.97 feet to the actual point of beginning of the land to be hereby excepted: thence continue North 1°57'34" East along said Easterly line of the railroad right-of-way a distance of 1185.38 feet to intersect said Southwesterly line of the highway right-of-way; thence South 53°44'03" East along said Southwesterly

line of the highway right-of-way a distance of 42.37 feet; thence South 1°57'34" West a distance of 423.44 feet; thence deflect to the right on a tangential curve having a radius of 3869.72 feet and a delta angle of 4°45'00" for 320.81 feet; thence South 6°42'34" West on a tangent to said curve for a distance of 105.81 feet; thence deflect to the left on a tangential curve having a radius of 3769.72 feet and a delta angle of 4°45'00" for 312.52 feet to the point of beginning.

Section 3. Filing. The Deputy City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State of the State of Minnesota, the Town Clerk of Baldwin Township, and the Sherburne County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and the approval of the filing of the Ordinance by the Minnesota Municipal Board.

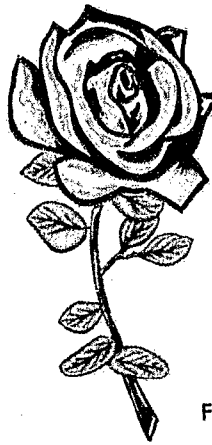
