WHEREAS: THE SKILLED INDIVIDUALS IN THE POSITIONS AS SCHOOL COUNSELOR ARE LICENSED BY THE STATE OF MINNESOTA; AND

WHEREAS: SCHOOL COUNSELORS IN THE STATE OF MINNESOTA PROVIDE SERVICE TO OUR YOUNG PEOPLE AND THEIR FAMILIES IN BOTH PUBLIC AND NON-PUBLIC SCHOOLS; AND

WHEREAS: SCHOOL COUNSELORS MAKE A POSITIVE DIFFERENCE IN THE LIVES OF MINNESOTA YOUTH; AND

WHEREAS: IT IS CRITICAL THAT GROUP AND INDIVIDUAL COUNSELING CONTINUE TO BE PRACTICED BY OUR SCHOOL COUNSELORS IN ORDER TO DEVELOP THE SOCIAL, EMOTIONAL, AND ACADEMIC GROWTH OF ALL STUDENTS; AND

WHEREAS: MINNESOTA SCHOOL COUNSELORS ARE DEEPLY INVOLVED IN ISSUES OF EQUALITY OF EDUCATION, HUMAN RIGHTS, AND THE REDUCTION OF RACIAL AND SEX BIAS WITHIN OUR EDUCATIONAL SYSTEM; AND

WHEREAS: WE RECOGNIZE THE AMERICAN PERSONNEL AND GUIDANCE ASSOCIATION AND ITS NATIONAL SCHOOL GUIDANCE WEEK OF MAY 3, 1982;

NOW, THEREFORE, I, ALBERT H. QUIE, GOVERNOR OF THE STATE OF MINNESOTA, DO HEREBY PROCLAIM THE WEEK OF MAY 3 THROUGH MAY 7, 1982 TO BE
