THIRD SERIES

ORDINANCE DECLARING CERTAIN LAND TO BE ANNEXED TO THE CITY OF NORTH MANKATO.

The Common Council of the City of North Mankato, Minnesota, does ordain as follows:


Section 1. The following tract of land, which abuts upon the city limits and which is or about to become urban or suburban in character, is in the County of Nicollet, State of Minnesota, and is described as follows:


The Northwest Quarter of the <sup>NW</sup> Southeast Quarter of the Northeast Quarter (~~SE~~ 1/4 of the SE 1/4 of (see notation) NE 1/4) of Section Two (2), Township One Hundred Eight (108) North, Range Twenty-seven (27) West,

is hereby annexed and declared to be part of the City of North Mankato and to be included in the corporate limits thereof.

Section 2. This ordinance shall take affect from and after its date of passage and publication.


