AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE
CITY OF COKATO TO INCLUDE CERTAIN UNINCORPORATED
PLATTED LAND (UNPLATTED LAND NOT EXCEEINDG 200 ACRES
IN AREA) ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated May 10, 1982, requesting annexation
of the territory hereinafter described was duly presented to the council on the
10TH day of May, 19 82; and

WHEREAS, the Petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town
board, or the governing body of any municipality whose boundaries abut upon the,
boundaries of the land to be annexed; and

WHEREAS, a hearing was not required; and,

WHEREAS, the land described in the Petition abuts upon the City limits at
the south boundary thereof;

The council of the City of Cokato, Minnesota, ordains:

Section 1. The City council hereby determines (1) that the territory
described herein abuts upon the city limits and is urban or suburban in character;
and (2) that none of the territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the city are hereby
extended to include the unplatted land described as follows and the same is hereby
annexed to and included within the city as effectually as if it had originally been
a part thereof:

The North 150 feet of the following described tract:
Commencing at the Northeast corner of the Southwest
Quarter of the Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section
Thirty-four (34), Township One Hundred Nineteen (119),
Range Twenty-eight (28), thence South on East line of
said forty acre tract, 47.5 rods; thence West 20 rods;
thence North 47.5 rods; thence East 20 rods to beginning,
all lines to run to government surveys, Wright County,
Minnesota.

Section 3. Filing. The City clerk is hereby directed to file certified
copies of this ordinance with the Minnesota Municipal Board, the Secretary of State,

the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

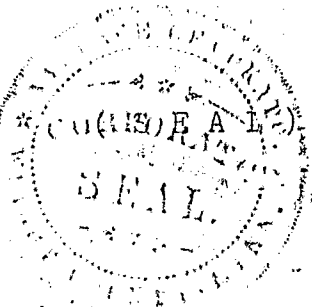

WHEREAS, a certain Petition dated May 10, 1982, requesting annexation of the territory hereinafter described was duly presented to the council on the 10th day of May, 1982; and

WHEREAS, the Petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was not required; and

WHEREAS, the land described in the Petition abuts upon the City limits at the south boundary thereof;

The council of the City of Cokato, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

Section 2. Territory Annexed: The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

The North 150 feet of the following described tract: Commencing at the Northeast corner of the Southwest Quarter of the Southwest Quarter (SW 1/4 of SW 1/4) of Section Thirty-four (34), Township One Hundred Nineteen (119), Range Twenty-eight (28), thence South on East line of said forty acre tract, 47.5 rods; thence West 20 rods; thence North 47.5 rods; thence East 20 rods to beginning, all lines to run to government surveys, Wright County Minnesota.

Section 3. Filing. The City clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.

Ivan Barnaal, being duly sworn, on oath says he is and during all times herein stated has been the publisher and printer of the newspaper known as The Cokato Enterprise and has full knowledge of the facts herein stated as follows: (1) Said newspaper is printed in the English language in newspaper format and in column and sheet form equivalent in printed space to at least 900 square inches. (2) Said newspaper is a weekly and is distributed at least once each week. (3) Said newspaper has 50 percent of its news columns devoted to news of local interest to the community which it purports to serve and does not wholly duplicate any other publication and is not made up entirely of patents, plate matter and advertisements. (4) Said newspaper is circulated in and near the municipality which it purports to serve, has at least 500 copies regularly delivered to paying subscribers, has an average of at least 75 percent of its total circulation currently paid or no more than three months in arrears and has entry as second-class matter in its local post-office. (5) Said newspaper purports to serve the City of Cokato in the County of Wright and it has its known office of issue in the City of Cokato in said county, established and open during its regular business hours for the gathering of news, sale of advertisements and sale of subscriptions and maintained by publisher of said newspaper or persons in his employ, subject to his direction and control during all such regular business hours and at which said newspaper is printed. (6) Said newspaper files a copy of each issue immediately with the State Historical Society. (7) Said newspaper is made available at single or subscription prices to any person, corporation, partnership or other unincorporated association requesting the newspaper and making the applicable payment. (8) Said newspaper has complied with all the foregoing conditions for at least one year preceding the day or dates of publication mentioned below. (9) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966, and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the publisher of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.

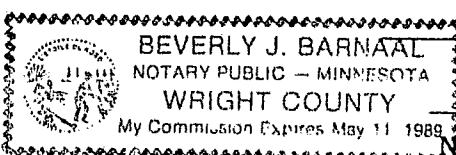

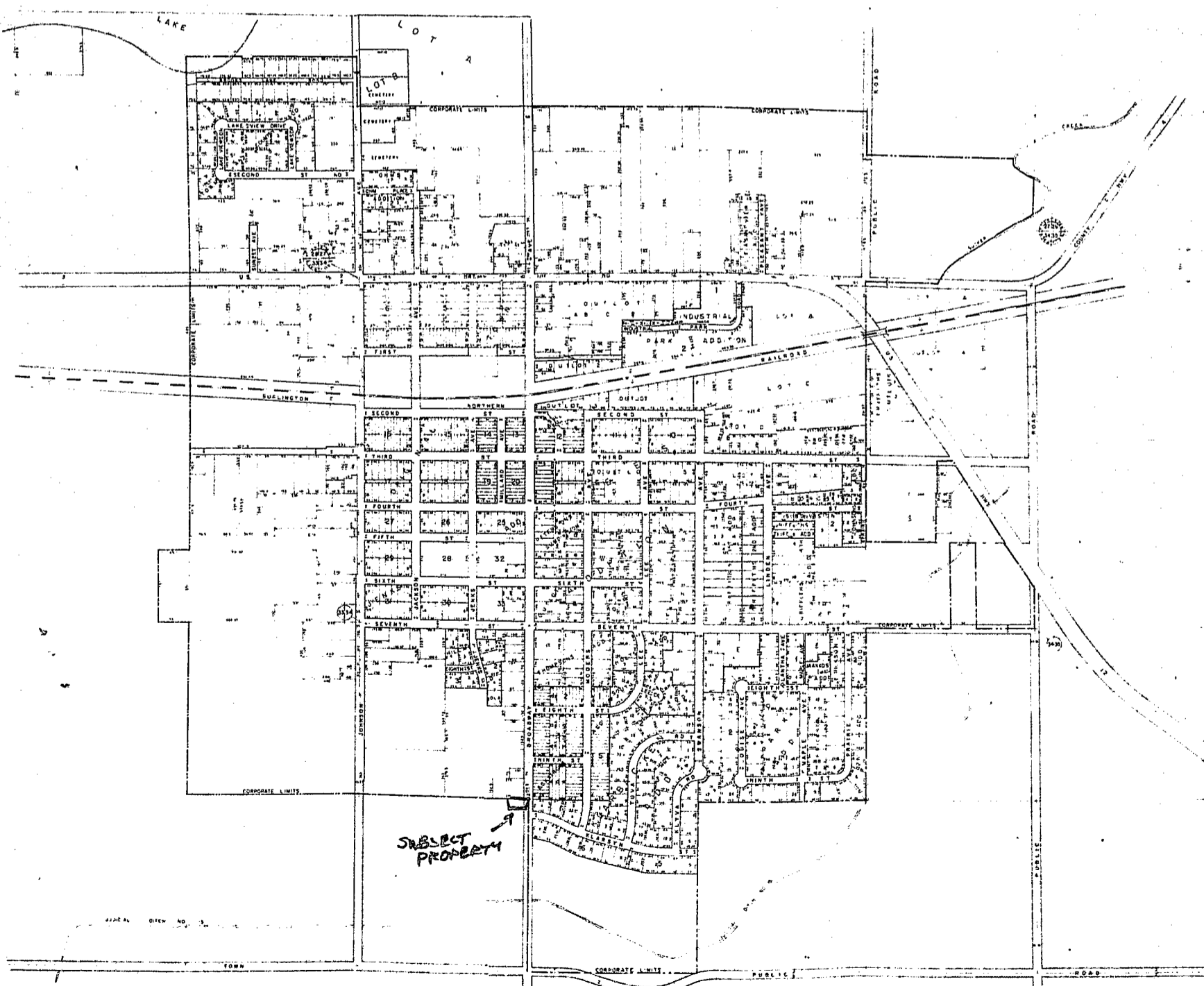
