RELATING TO APPOINTMENT OF PAT MCFARLAND TO
MINNESOTA EMERGENCY EMPLOYMENT DEVELOPMENT ACT (MEED) TASK FORCE

WHEREAS, the Minnesota Emergency Employment Development Act establishes a task force to advise the Emergency Employment Act Coordinator on administration of the Act; and,

WHEREAS, the Task Force shall consist of nine members as follows: the coordinator, the Commissioner of Economic Security, the Commissioner of Energy and Economic Development, the Commissioner of Labor and Industry, the Commissioner of Public Welfare, a representative of labor, a representative of business, a representative of non-profit employers, and an employment administrator; and,

WHEREAS, Pat McFarland, Executive Director of the Anoka County Community Action Programs, is being considered as a representative of non-profit employers on the Task Force; and,

WHEREAS, Pat McFarland has distinguished himself as an effective administrator and spokesperson for unemployed and disadvantaged residents of Anoka County:

NOW, THEREFORE, BE IT RESOLVED by the Anoka County Board of Commissioners that it supports the appointment of Pat McFarland as the representative of non-profit employers on the Task Force.

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the coordinator of the Minnesota Emergency Employment Development Act Program, the Secretary of State and the Office of the Governor of the State of Minnesota.

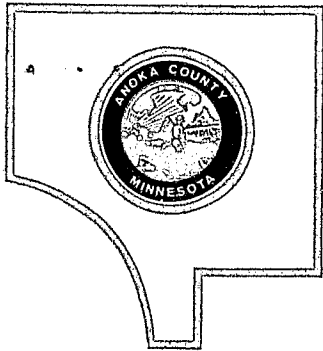
