
Dear Mr. Traxler:

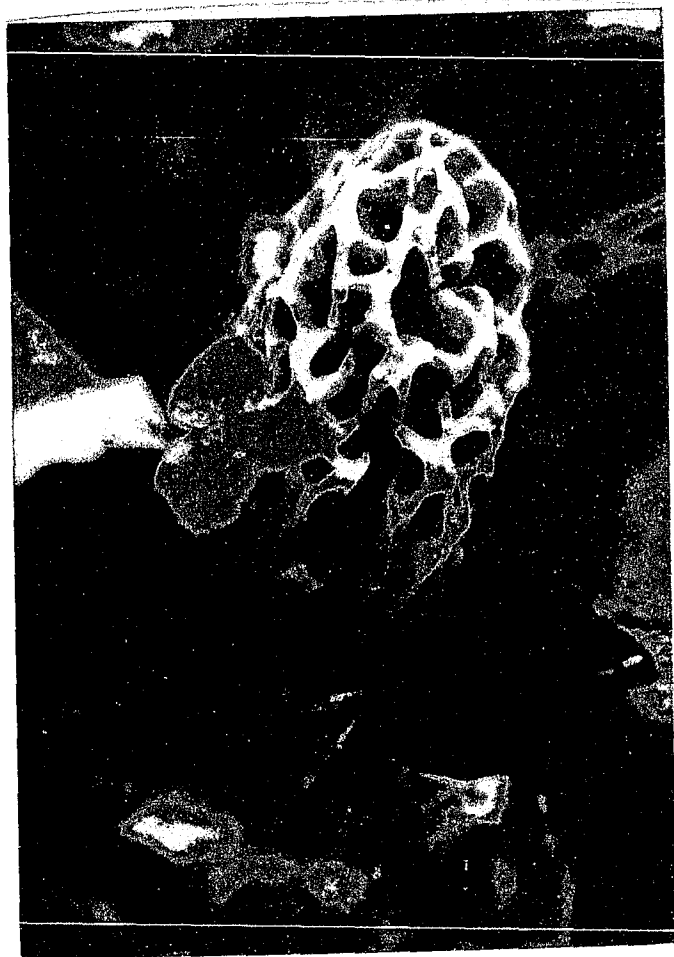
