NOTICE OF ORDINANCE AMENDMENT  
CITY OF GRAND RAPIDS, MINNESOTA

The City Council of the City of Grand Rapids Ordains:

An Ordinance Extending the Corporate Limits of the City of Grand Rapids, Minnesota To include the W208' of the SW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 15-55-25

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory abuts upon the corporate limits of the City in the northeastern portion of Grand Rapids; and

WHEREAS, this territory has petitioned for annexation to the City of Grand Rapids, by 100% of the property owners, and

WHEREAS, the property owners wishes to annex to the city in order to construct a student housing project so that city sewer and water can be provided; and

WHEREAS, Grand Rapids Township and the County of Itasca has submitted waivers to waive the requirement that the city has to wait 90 days before the city ordinance can be adopted.


NOW THEREFORE, BE IT RESOLVED, The City Council of the City of Grand Rapids ordains:

Section 1. Territory Annexed. West 208' of the SW $\frac{1}{4}$  of SE $\frac{1}{4}$ , Section 15-55-25.


Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Itasca County, Grand Rapids Township Board, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication; the filing of certified copies as directed in Section 2; and upon approval of the Minnesota Municipal Commission.


