ORDINANCE NO. 79-3

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BLOOMING PRAIRIE TO INCLUDE CERTAIN UNPLATTED LAND, NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated July 2, 1979, requesting annexation of the territory hereinafter described was duly presented to the council on the 2nd day of July, 1979; and,

WHEREAS, the Petition was signed by all owners; and,

WHEREAS, a Waiver of Objection has been filed by the Blooming Prairie Town Board waiving all objections to the annexation; and,

WHEREAS, there is no municipalities whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS, the land described in the Petition abuts upon the city limits at the South boundary thereof; and,

WHEREAS, the land described in the Petition is now urban or suburban in character;

The council of the City of Blooming Prairie, Minnesota, ordains:

Section 1. The City Council hereby determines:

1. That the Territory described herein abuts upon the city limits and is urban or suburban in character; and
2. That none of the territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Parcel One: The South 150.0 feet of the tract of land described as: Commencing at a point 693.0 feet east and 989.8 feet South and 567.0 feet East of the Northwest corner of the Northwest Quarter of the Northeast Quarter of Section 36, Township 105 North, Range 19 West, Steele County, Minnesota, running thence South 470.0 feet, thence East to the U.S. Highway 218, thence in a Northwesterly direction along the west side of U.S. Highway 218 to a point 989.8 feet south of the North line of Section 36, thence West to the point of beginning.


Parcel Two: A tract of land in the Southeast Quarter of the Northeast Quarter of Section 36, Township 105 North, Range 19 West commencing at a point fifteen hundred and eight (1508) feet east and fourteen hundred and fifty nine and eight tenths (1459.8) feet south of the northwest corner of the northwest quarter of the northeast quarter in Section 36, Township 105 North, Range 19 West, thence South 197.6 feet, thence east to west side of U.S. Highway #218, thence northwesterly along west side of U.S. Highway #218 to a point fourteen hundred and fifty nine and eight tenths (1459.8) feet south of the north section line of Section 36, Township 105 North, Range 19 West, thence west to point of beginning.

Parcel Three: A tract of land described as: Commencing 1911 feet East and 1657.4 feet South of the Northwest Corner of the Northwest Quarter of the Northeast Quarter of Section 36, Township 105 North, Range 19 West, thence 290 feet West, thence 150 feet South, thence 437.66 feet East to the West right-of-way line of U.S. Highway #218, thence 56.37 feet northwesterly along the highway right-of-way line, thence 121.55 feet West, thence 100 feet north of the point of beginning; Being in Southeast Quarter of Northeast Quarter of Section 36, Township 105 North, Range 19 West.


Section 3. Filing. The city clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon it's passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.
