



AGREEMENT BETWEEN THE CITY OF CANNON FALLS    )  
AND THE TOWN OF CANNON FALLS PURSUANT TO        )  
MINNESOTA STATUTES 414                                )

ORDER

-----  
WHEREAS, a joint resolution for orderly annexation was adopted by the City of Cannon Falls and the Town of Cannon Falls and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be immediately annexed to the City of Cannon Falls pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, the resolution indicated city and town agreement that the mill levy of the City of Cannon Falls on the property to be annexed shall be increased in substantially equal proportions over a period of six years to equality with the mill levy of the city; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on June 12, 1986, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Cannon Falls, Minnesota, the same as if it had originally been made a part thereof:

Government Lots 2, 3, 4, 5, 9, and 10, Section 6, Township 112 North, Range 17 West, Goodhue County, Minnesota and that part of Government Lots 8 and 11 of said Section 6 lying northwesterly of the centerline of State Highway No. 20.

AND


Government Lots 3, 4, 5, and 6, Section 7, Township 112 North, Range 17 West, Goodhue County, Minnesota and that part of Government Lot 2 of said Section 7, lying westerly of the centerline of State Highway No. 20.

IT IS FURTHER ORDERED: That the mill levy of the City of Cannon Falls on the property herein ordered annexed shall be increased in substantially equal proportions over a period of six years to equality with the mill levy of the property already within the city.

IT IS FURTHER ORDERED: That the effective date of this order is June 12, 1986.
